## **Highlights**

The Melbourne Royal Dairy Competition welcomes exhibitors of all ages to interact, mentor and learn, showcasing the great tradition of dairy cattle showing to a large audience of Melbourne Royal consumers.

The 2022 Melbourne Royal Dairy Cattle Competition welcomes the return of full in-milk classes and breed judging. The competition offers amazing prize money that includes a full offering of junior heifer, intermediate cow and senior cow classes.

Staggered arrival times will enable flexibility for exhibitor bump-in, before judging of Dry Classes at 5pm Friday 23 September and In-Milk Classes at 10:30am on Saturday 24 September.

#### **Dairy Youth Handlers Classic**

Aiming to attract the best handlers from across the country, the Dairy Youth Handlers Classic returns this year with Junior and Senior classes. With generous prizemoney up for grabs, the competition provides an opportunity for handlers to showcase their skills in front of large crowds and industry peers.

#### **All New BPI Class**

In addition to the large range of existing classes available as part of the Melbourne Royal Dairy Competition, this year we have added a Best BPI class. BPI data will be sourced from the relevant breed societies with the winner awarded in the judging ring.

#### **Mr Glen Gordon**

Glen Gordon and his family run Gorbro Holsteins, home to 600 Registered Holsteins on 485 Hectares in Cohuna, North-West Victoria. Glen has been showing cows since he was 9 years old, starting with Elmar Holsteins and then Corra Lea Holsteins.

His passion grew from there, with Gorbro experiencing their fair share of showing success over the past decade, including 2019 Supreme Senior Champion at International Dairy Week.

Glen says, "Showing is still very important to our business. We select our show team on cows that are great paddock cows as well as great ring cows – the type of cows that breeders want to look at and want to breed from. Whether it's International Dairy Week, Royal Shows or the local Cohuna Show, we always make sure our show team is one that we can be proud to stand behind."

Registering their first cow in 1998, the Gordon family have been Holstein Australia members for 21 years and were crowned All-Australian Premier Breeder in 2017 and Premier Breeder at the 2019 National Herd Development Victorian Winter Fair. 2019 was a big year for Gorbro, taking out the Holstein Australia Cow of the Year Award with 14-Year-old 'Orchard Vale Informer Tiffany'. Glen has judged at the Sydney Royal Show, NSW Spring Holstein Show and was judge of the Holstein Fresian NZ on farm competition.

We welcome Glen to the 2022 Melbourne Royal Show.

## Important Information for Dairy Cattle Exhibitors

### All Dairy Breeds National Show Ring Code of Ethics

Melbourne Royal subscribes to the Code of Ethics devised by the All Dairy Breeds Show Ring Committee (ADBSRC). The ADBSRC consists of representatives from all Australian dairy breeds and has the primary purpose of developing a national code of show ring ethics to ensure dairy animals presented for exhibition will be in their natural conformation and structure, free from modification caused by unethical fitting practices. The most recent update to these regulations occurred in October 2019 and we encourage all exhibitors to be familiar with its content. We congratulated the ADBSRC for driving this initiative which underpins a national and consistent approach to conduct at dairy shows.

#### **Dairy Youth Classic Entry Information**

Entry into the Dairy Youth Handlers Classic is FREE for those entered in the Melbourne Royal Dairy Competition. For heifers not entered in the Ordinary Classes, standard entry fees apply. Entry forms for the Dairy Youth Handlers Classic (only) are available both via online entry and by hard copy from the Superintendents office upon arrival at the Showgrounds and will be accepted up until 12:00pm Friday 23 September 2022.

#### **Prize Money for Ordinary Classes**

Prize money will be offered for all classes as detailed in the Schedule. This will be paid via EFTPOS transfer following the culmination of the Melbourne Royal Show. No prizemoney will be distributed on the day of competition.

#### Entry and Nomination Processes, Late Entries

Exhibitors must nominate all Exhibit/s at time of Entry. Exhibitors will be able to substitute nominated entries prior to the close of substitutions.

If you no longer wish to bring a nominated Exhibit/s, please use the Substitution Form to advise Melbourne Royal of the Exhibit/s you are withdrawing and the details of the Exhibit/s replacing it. Substitutions and late entries will be accepted up until Wednesday 31 August 2022.

#### **Catalogues**

Catalogues will be available for download from the Melbourne Royal website.

#### **Milking Equipment**

All exhibitors that have entered in milk heifers are required to provide their own portable milking equipment. Melbourne Royal will provide a location for the disposal of the milk but will not provide any milking equipment for exhibitors.

#### **Bedding Material**

Upon arrival all exhibits will be provided with a bed of sawdust. Any exhibitor wishing to purchase straw can do so at the Melbourne Showgrounds fodder merchant.



#### **Important Information for Dairy Cattle Exhibitors**

### Sawdust Bedding for Cattle Principles for Good Management

To achieve the best results from bedding cattle on sawdust, the following system of management is recommended;

- a) Pick up manure at every opportunity.
- b) Place hay in feeders and avoid feeding excessive amounts.
- c) Avoid water spillage in stalls.
- d) Regularly smooth out the bed with the aim of assisting drying.
- e) Consider using rubber matting for front half of bed.
- f) Do not dig out the wet patches.
- g) Do not disturb the bedding base.
- h) Keep the top of the bed loose.

Experience has shown that properly managed bedding will last a full Show with little need for top up bedding, particularly with some classes of livestock.

#### **Fodder Aisles**

Incorporated into the design of the stalls is a fodder aisle, which negates the need for fodder lofts or storage in the stalls. Please note that large square bales and small round bales cannot be stored in these aisles.

Exhibitors are not permitted to stack feed in the Livestock Pavilion except in the designated fodder aisles. Stock requisites can be obtained from the Fodder Merchant who will be situated on the Showgrounds.

#### **Fodder Supplies**

Fodder will be available from an onsite fodder supplier throughout the Melbourne Royal Show.
All exhibitors will be forwarded payment options and price lists once the tender process is completed.

#### **Truck Parking and Shuttle Bus**

Melbourne Royal will be running a free shuttle bus service between the truck and float carparks and The Livestock Pavilion during designated arrival and departure times as listed on the timetable.

The service will be available for all exhibitors who have pre-purchased Truck Parking on their entry form.

#### **Clipping of Exhibits**

A limited number of clipping frame spaces will be available, provided an application for space and a \$50 fee (inc. GST) accompanies the Dairy Cattle Entry.

Each Exhibitor is restricted to one clipping frame only.

#### **Entry Fees and Bedding Fees**

Entry fees for Dairy Cattle breeds are as follows:

- \$45 each (GST free) for Melbourne Royal Members
- \$75 each (GST free) for Non Melbourne Royal Members
- \$25.00 Administration fee (Enter online and save)

#### **Important Information for Dairy Cattle Exhibitors**

#### **Property Identification Code**

The Property Identification Code of the Melbourne Showgrounds is 3MWAG001.

#### **Nose Rings**

Please note that it is not acceptable for animals to be rung through the nose with wire. If an exhibitor chooses to lead an animal using a nose ring it must be a fixed bull ring or nose clip. If an exhibitor is found to be using anything other than the aforementioned fittings, the animal may be disqualified from showing and the exhibitor may face penalties in line with the regulations of this competition.

#### **Pestivirus**

Please note that all Beef Cattle, Beef Carcase and Dairy Cattle Exhibits must be tested for Pestivirus (Bovine Viral Diarrhoea Virus) and certified as non PI (Persistently Infected). Exhibitors must provide a signed veterinary certificate or laboratory report, listing animals and their identification upon entry.

1. The Regulations appearing in this Schedule form part of the Royal Agricultural Society of Victoria's (Melbourne Royal's) General Regulations and conditions of entry to an Event at the Royal Melbourne Show (Show). In the event of any inconsistency between the General Regulations and these Regulations, the General Regulations shall prevail to the extent of the inconsistency unless the General Regulations provide otherwise.

#### **Close of Entries and Substitutions**

- All entries must be received at Melbourne Royal Centre, located at Melbourne Showgrounds, Epsom Road, Ascot Vale, 3032, by 5:00pm on the nominated Entry Close date.
- All associated fees (i.e. bedding, storage lockers, catalogues and clipping frame space) must be paid at the time of entry.
- 4. A completed National Cattle Health Statement must be submitted when entering.
- Exhibitors are required to submit the name/s of Exhibits, registration numbers and classes to be entered at the time of entry.
- 6. There will be no late entries accepted under any circumstances unless clause 7(b) is complied with. The onus is entirely on the Exhibitor to submit particulars on time.
- 7. Substitutions of exhibits will be accepted for the Dairy Cattle Section using the official Substitution Form up until 5:00pm on the nominated Substitution Close date, noting:
  - a) Team selection can only be made from those officially entered and cannot exceed the number of spaces nominated. One space will be provided to each Exhibit.

- b) Late Entries will only be accepted if
  Melbourne Royal is contacted in writing on
  or before the nominated late entries date.
  Late entries will incur a cost of \$200, in
  addition to bedding and other fees. Late
  entries will be accepted from those not
  already exhibiting. Lockers for late entries
  will also incur a cost at the usual fee, but
  will only be provided if available. Melbourne
  Royal cannot guarantee to fulfill such a
  request.
- 8. There is no restriction on the number of Exhibits entered in each class.
- In accordance with General Regulation 9.2,
   Melbourne Royal reserves the right to amend,
   consolidate or cancel classes offered in this
   competition schedule.

#### **Accommodation Lockers**

10. Accommodation locker prices are detailed in the Schedule. Key deposits must be paid at time of entering. Key deposit refunds will be issued on return of key. Due to limited accommodation lockers, Melbourne Royal reserves the right to limit allocation in an effort to accommodate all Exhibitors.

#### **Truck Parking**

- 11. Parking for trucks and floats will be available.

  Apply by completing the relevant section when entering.
- 12. There is to be no camping in the truck park under any circumstances.



13. Any vehicle, including trucks, stock transports, trailers, and horse floats, located on the Showgrounds, or any area leased by Melbourne Royal, shall be at the sole risk of the owner.

Melbourne Royal accepts no responsibility for any loss or damage, including loss or damage caused by negligence of Melbourne Royal, its officers, employees, or agents to any vehicle, or the contents of any vehicle, located on Melbourne Royal property or any area leased by Melbourne Royal.

#### **Arrival and Departure of Exhibits**

14. Access to the Showgrounds and Livestock Pavilion is strictly limited to the nominated arrival and departure times. Please refer to these times in Important Information for Exhibitors.

#### **Eligibility of Exhibits**

- An animal shall not be admitted to the Showgrounds, unless it is entered for competition or exhibition.
- 16. Bull Classes are not offered at the Show. Dairy breed bulls shall not be admitted to the Showgrounds.

#### **Standard of Exhibits and Inspections**

- 17. The standard of Exhibits shall be subject to the Rules and Regulations pertaining to the Breed Standards as accepted by the relevant Breed Society and as approved by Melbourne Royal.
- Every animal exhibited at the Show will be subject to a breed standard inspection, carried out by an Inspector appointed by Melbourne Royal.
- Each breed society or association will be invited to put forward nominations for these appointments for their breed, and these nominations will be considered by Melbourne Royal.

- 20. Exhibitors are required to have their stock attended and clean in readiness for inspection by no later than 8:00am on the relevant day. The Inspector(s) shall on the relevant day make every effort to submit their report to Melbourne Royal.
- 21. Exhibitors shall not be permitted to exhibit any cattle bearing marking brands or tattoos that are not consistent with those shown on the relevant Breed Society records or submitted by the Exhibitor when entering.
- 22. Exhibitors are strongly advised to inspect marking brands and tattoos prior to lodging entry forms and before departure for the Show.
- 23. Without prejudice to any other applicable rules, if the relevant inspector determines that any animal entered for exhibition:
  - a) is not true to type;
  - b) is not of sufficient merit as to be worthy of exhibit in the class or classes for which it is entered;
  - c) has not been adequately prepared for the Show;
  - d) bears any marking brand or tattoo inconsistent with the markings brand or tattoo disclosed in the relevant entry form or Breed Society records or whose tattoo is not clearly legible; and/ or
  - e) is in breach of the rules under the heading "Tampering of Exhibits";
  - then such animal shall be deemed to be ineligible for exhibition at the Show.
- 24. Any animal infected by ringworm or warts shall be deemed to be ineligible for exhibition at the Show. The Inspectors shall report any animal which they believe to be infected by ringworm or warts and the Melbourne Royal's Veterinary Surgeon shall inspect such animal for the purpose of determining whether the animal is so infected.



- 25. Without prejudice to the General Regulations, the determinations of the Inspectors or of the Veterinary Surgeons on any matter shall be subject only to appeal to the Chief Steward in the Dairy Cattle Section who shall make such determinations and directions as they deem appropriate. Such appeal shall be accompanied with a deposit of \$50 which may be forfeited to Melbourne Royal if in the sole opinion of the Chief Steward the appeal is unfounded, frivolous or vexatious.
- 26. The Inspectors, Veterinary Surgeons, Chief Stewards, or their assistants shall not be required to furnish to the Exhibitor any reasons for their determinations or directions nor to give the Exhibitor any right to be heard on any matter in question.
- 27. Notwithstanding any other provision in the regulations, where Melbourne Royal determines that any animal entered in the Competition has received hormones, then such animal shall be deemed to be ineligible for exhibition at the Show. Any determination made by Melbourne Royal pursuant to this regulation shall be final.
- 28. Melbourne Royal may make or cause to be made, at any time during the period of exhibition, an inspection or any test of an Exhibit to determine whether a breach of the regulations under the heading of Standard of Exhibits and Inspections has occurred. If, as a result of a breach of any of these regulations, an animal is deemed to be ineligible for exhibition at the Show, Melbourne Royal may by notice to the Exhibitor require the animal be forthwith removed from the Showgrounds. The Exhibitor, upon receipt of such notice, shall forthwith remove such animal and, failing such removal by him within the time prescribed by Melbourne Royal, Melbourne Royal may remove the animal or cause the animal to be removed and all costs and expenses of removal shall be borne by the Exhibitor and shall be refunded to Melbourne Royal. Any determination made by Melbourne Royal pursuant to this regulation shall be final.

29. If an award has been made to an Exhibit deemed to be ineligible under these regulations, any prize awarded will be forfeited and, subject to General Regulation 11.5, Exhibits in the next order may be promoted to that prize.

#### **Tampering of Exhibits**

- 30. Notwithstanding General Regulation 8.4, no Exhibitor shall be permitted to exhibit any cattle which, in the opinion of Melbourne Royal, displays evidence of being tampered with or, in the definition of the class in which it is entered, an animal entered for exhibition or competition is not presented in its natural conformation and has no preparation other than normal feeding and fitting with the exception of normal dressing of hair, hoofs and horns.
- 31. The following practices are strictly prohibited:
  - a) Treating an animal externally including the udder with an irritant or other foreign substance not registered for use on cattle within the Commonwealth of Australia, stimulating device or electrical appliance.
  - b) Surgically or unethically inserting any prohibited chemical, drug, gas, liquid (including milk), matter of foreign substance into the udder to artificially enhance or change the natural shape or appearance of the udder. This includes, but is not limited to:
    - i) Dextrose:
    - ii) Pure alcohol;
    - iii) Gas of any sort;
    - iv) Foam;
    - v) Silver protein;
    - vi) Silver nitrate; and
    - vii) Transferring milk between quarters.
  - Using device or product to artificially create or enhance the udder crease.



- d) Administering an injected or applied anesthetic to alter the carriage of the tail or other body parts.
- e) Surgically or unethically inserting any matter of foreign substance under the skin or into any body cavity to change the natural contour or appearance of the animal's body. This includes the administration of body fluids by stomach tube or other similar device unless performed under the direct supervision of the Show Veterinarian for medical treatment.
- f) Manipulation of the teat by surgically or unethically inserting or applying any object or foreign substance to alter its normal direction such as to unnaturally hold plumb or to alter its length (i.e. teat setting).
- g) Excessively manipulating top line and/or tail head hair beyond 3.8 cm (1.5 inches). Exhibitors have only one opportunity per Show to check-in ringside and the animal will not be allowed in the ring for the duration of the Show.
- by any circumstances before or during the Show. Including, but is not limited to:
  - i. Any drug not registered for use on cattle in Australia;
  - ii. Anabolic steroids;
  - iii. Growth or milk promoting hormones other than those in Regulation 32(g);
  - iv. Diuretics and sedatives other than those in Regulation 32(g);
  - v. Amphetamines;
  - vi. Prescribed drugs without a veterinarians label attached;
  - vii. Prescribed drugs with a veterinarians label attached but used outside the normal time frame allowed for the use of that drug or drugs not used in accordance with the label instructions;

- viii. Drugs used from an unmarked bottle, tube or container; and/or
- ix. Any drug that is illicit or illegal in Australia.
- 32. Dairy cattle exhibitions are conducted under standards for evaluating conformation established by various Breed Societies with specific breed characteristics taken into consideration by the Judge. Animals will be groomed and prepared for the Judge's evaluation in order to display the animal's natural contour, confirmation, performance and mobility. Specifically:
  - a) External applications of cosmetics that affect only appearance may be used, including hoof polishes, hoof trimming, glitter, hair products on the top line and other areas of the animal.
  - b) Fake switches are permitted.
  - The use of imitation or artificial hair is permitted for use on the top line and tail head provided Regulation 31(g) herein is not contravened.
  - d) Teat sealing (with a teat sealant registered for the use on cattle within the Commonwealth of Australia) is permitted but the practice is not encouraged. Teat sealants are only to be used according to the manufacturer's application protocols.
  - e) The use of udder treatments is allowed provided the product is registered for use of cattle within the Commonwealth of Australia.
  - f) The following allowed practices require an Exhibitor Declaration (see appendix) to be completed and returned to the Superintendent before an animal is allowed to enter the ring
    - The use of intra-urine and intra-vaginal controlled drug release devices is allowed but exhibitors must complete an Exhibitor Declaration declaring



- the use of such a device and including the name of the ET technician or vet involved in the case of an ET program. Only one such device is allowable and Dairy Cattle are subject to examination.
- ii. The use of drugs before and during a Show is allowed under certain conditions. All pharmaceuticals and nutraceuticals must be delivered according to label instructions, including dose rate, frequency of use, method of application and purpose.
- g) Drugs allowed that have been prescribed by a veterinarian based on a therapeutic need as part of an animal treatment plan and declared in the Exhibitor Declaration:
  - i. Anti-inflammatories (Flunixin meglumine, Meloxicam, Tolfenamic acid, Ketoprofen, Dexamethsasone);
  - ii. Antibiotics, including intramammary antibiotics;
  - iii. Diuretics (Furosemide (INN), Frusemide (BNN));
  - iv. Anti-histamines (Tripelennamine HCI, Chlorpheniramine maleate);
  - v. Sedatives (xylazine, acepromozine); and/or
  - vi. Hormones (Oxytocin, Prostaglandin, Gonadatrophin (GnRH)).
- h) Substances allowed without an exhibitor declaration:
  - i. Vitamins and minerals; and/or
  - ii. Glucose.
- 33. It is the Exhibitor's responsibility to ensure the animal is not subject to prohibited practices, prior to and whilst on the Showgrounds.
- 34. Melbourne Royal may make or cause to be made, any test of any Exhibit to determine whether any drug or other substance has been administered to the Exhibit and may take possession of any such Exhibit for any

- of the aforesaid purposes and detain such Exhibit for such period as the Melbourne Royal deems necessary. Procedures for the testing of prohibited substances may include random tests on Exhibits.
- 35. Should a positive test to a prohibited substance or practice result, any costs associated with testing will be borne by the Exhibitor.
- 36. In accordance with General Regulation 8.1, should a positive test to a prohibited substance or practice result, Melbourne Royal reserves the right to forfeit an award.

#### **Tinting and/or Colouring of Coat**

37. Should Melbourne Royal or appointed inspector, be of the opinion that the coat of any Exhibit has been tinted and/or coloured in any way, then such an animal shall be deemed to be ineligible for exhibition at the Show.

#### **Health Declaration**

- 38. All Exhibits must be declared free of Brucellosis, Johne's Disease and other notifiable diseases defined under the Victorian Livestock Disease Control Act (1994).
- 39. As a condition of entry, all cattle Exhibitors are required to complete the National Cattle Health Declaration (NCHD) (Version 16/04/20).
- a) The NCHD must be signed by the owner or the person responsible for the cattle who in doing so accept personal responsibility for its truth and accuracy.
- 40. Cattle entered must not be subject to quarantine or restriction with respect to any other notifiable disease.

#### **Johne's Disease**

- 41. Unrestricted entry, with all exhibitors required to complete the National Cattle Health

  Declaration (Version 16/04/20) and submit with entries.
  - a) All Exhibitors must provide a correct Dairy Assurance Score with their entries.
  - b) Exhibits will be stalled based on the Dairy Assurance Score provided.
  - c) Exhibitors may also need additional certification to move between zones or between States. Please check with the local veterinary authority.

### Pestivirus (Bovine Viral Diarrhoea Virus)

42. All cattle entered in the Dairy Cattle
Competition, must be tested for Pestivirus
(Bovine Viral Diarrhoea Virus) and certified as
non-PI (Persistently Infected). Certification of
testing and proof of non-PI status is required
in the form of a signed Veterinary Certificate
or Laboratory Report, clearly listing animals
and their identification. Animals previously
tested and certified as non-PI animals are not
required to be re-tested, however certification
must be supplied with your entries.

#### **Animal Identification**

43. All Exhibitors must comply with the Property Identification Code and National Livestock Identification Scheme legislation of Victoria, and must provide the Property Identification Code (PIC) for the property/properties where the cattle originate from on their Entry Form/s. Exhibits not appropriately identified by means of an electronic identification will be deemed ineligible.

#### Registration

43. All Exhibits must be entered in the name of the registered owner as at time of exhibiting.

#### **Neck Numbers**

- 44. Neck numbers corresponding to the Exhibit numbers in the catalogue must be worn by the Exhibits when entering the ring to appear before the Judge or when otherwise required.
- 45. Neck numbers must be obtained by the Exhibitor from the Cattle Superintendent's Office.

#### **Absence of Exhibit**

- 46. Notwithstanding Regulations 6.2 and 6.3, Exhibitors may withdraw exhibits provided that written notification is given to Melbourne Royal by 5:00pm on the nominated Withdrawal Date listed in the Important Information for Exhibitors. The full bedding fee will be refunded for each head of cattle withdrawn in writing by this time.
- 47. If an Exhibitor fails to show any Exhibit entered in the Show without having given notice in accordance with these Regulations, that Exhibitor may be prohibited from showing any further Exhibits.

### Hours of Opening of Pavilions and Cleaning

- 48. The Livestock Pavilion will be opened to the public from 9:30am to 6pm daily, unless closed by the Cattle Superintendent or Melbourne Royal staff.
- 49. Exhibitors shall, to the satisfaction of the Cattle Superintendent;
  - Keep each stall allotted to them and their stock in a clean and proper condition throughout the Show.
  - b) Clean out their stalls each day, no later than the times advised to Exhibitors by Melbourne Royal staff.
  - c) Clean their area regularly. Refuse must be deposited in the manure bins provided.
     Manure must not be deposited in the alleyways or general purpose rubbish bins.

- d) General purpose rubbish must not be deposited in manure bins.
- To assist in the transfer of manure to the bins provided, Exhibitors must bring own cleaning tools.
- f) Stock must not be left unattended outside pavilions at any time.
- 50. Dairy Cattle must not be rugged between the hours of 10:00am and 6:00pm.

#### **Bedding**

- 51. The following regulations apply to bedding costs and bedding materials.
  - a) Sawdust bedding will be provided for all Exhibits at the Showgrounds.
  - b) Exhibitors are required to pay a bedding fee at the time of entry.

#### **Fodder Storage**

52. Exhibitors are not permitted to stack feed in the Livestock Pavilion except in the designated fodder aisles. Stock requisites can be obtained from the fodder merchant who will be situated on the Showgrounds.

#### **Clipping of Exhibits**

- 53. A limited number of clipping frame spaces will be available, provided an application for space and a fee is paid when entering. Each Exhibitor is restricted to one clipping frame only.
- 54. All clipping frames must have secure flooring and face the front of the stall only. Clipping frames must only be kept in their designated area. Failure to adhere to this rule will result in automatic removal of the clipping frame.

#### **Security of Animals**

- 55. All Exhibits must be provided with effective halters and be thoroughly broken to lead.
- All calves must be securely tethered at all times.
- 57. Each Exhibitor shall ensure that each of their Exhibits is securely tethered in its stall and that Exhibits are not left unattended.

58. If in its absolute discretion Melbourne Royal determines any Exhibit or Exhibits of stock to be dangerous for any reason whatsoever, Melbourne Royal may by notice to the Exhibitor require the animal or animals concerned to be forthwith removed from the Showgrounds. The Exhibitor upon receipt of such notice shall forthwith remove such animal and failing such removal by the Exhibitor within the time prescribed by Melbourne Royal, Melbourne Royal may remove the animal or cause the animal to be removed and all costs and expenses of removal shall be borne by the Exhibitor and shall be refunded to Melbourne Royal.

#### **Sales and Notices**

59. Exhibitors are permitted to display cards over the stalls stating that an animal is for sale provided such cards do not exceed 30cm x 25cm in size. No other advertisements or notices (except by permission of Melbourne Royal) are permitted on or in any stalls or buildings.

#### **Stud Identification Notice**

60. Each Exhibitor is permitted to display one sign 60cm x 120cm in size provided that such sign carries only the stud name, address, telephone number, facsimile number and/or e-mail address.

#### **Judging**

- 61. Exhibits shall be present at the appropriate judging ring and ready to enter the judging ring at the time specified in the Timetable for the event to take place. Exhibits shall enter the judging ring immediately upon request by the appropriate Steward.
- 62. Persons in charge of Exhibits must in no circumstances leave their Exhibits unattended at or in the judging ring.
- 63. Persons in charge of Exhibits at or in the judging ring shall not address the Judge unless authorised by the Chief Steward or the Judge.

- 64. Judges shall have the right to order that an Exhibit be milked dry before awarding a prize.
- 65. All attendants leading stock in the judging ring or on Grand Parade shall wear uniform white coats or approved breed uniform. Such white coat or uniform must in no way show any insignia or any descriptive markings indicating the Exhibitor's name and/or stud name or prefix.

#### **Prize Ribbons**

66. Ribbons may be awarded throughout the Dairy section in accordance with the following table:

Exhibits entered	Ribbons to be awarded
8 and under	4
9 and over	6

#### **Most Successful Exhibitor Awards**

- 67. Points will be accrued by the Steward during the judging of each breed, based on the allocation below (points are not accrued for Group Classes).
  - a) Ordinary Classes Point Allocation:

First Prize	3 points
Second Prize	2 points
Third Prize	1 point

b) Championship Point Allocation:

Junior Champion	3 points
Reserve Junior Champion	2 points
Intermediate Champion	3 points
Reserve Intermediate Champion	2 points
Senior Champion	3 points
Reserve Senior Champion	2 points
Supreme Exhibit	2 points

c) In the event that two or more Exhibitors secure an equal number of points, the Exhibitor gaining the greatest number of first prizes shall be the winner.

- d) For the purposes of calculating the Most Successful Exhibitor, when an Exhibit receives an award and that Exhibit is held in multiple ownership, the relevant points will be divided equally amongst the multiple owners
- e) A special sash will be presented to the winner.



#### 1. DEFINITIONS AND INTERPRETATION

#### 1.1 **DEFINITIONS**

The following definitions apply unless the context requires otherwise.

**Agent** includes any person, agent, association or corporation engaged by or on behalf of the Exhibitor and any person acting or purporting to act on the Exhibitor's behalf (including any person who is an invitee of the Exhibitor and regardless of whether the person is remunerated or not).

**Assistant Chief Steward** means the person occupying or acting in the position of Assistant Chief Steward of a section.

**Body** includes any society, organisation or body within or outside Australia having similar objects to Melbourne Royal and, without limitation, includes:

- Royal Agricultural Society of the Northern Territory Inc;
- Royal National Agricultural & Industrial Association of Queensland;
- Royal Agricultural & Horticultural Society of South Australia;
- · Royal Agricultural Society of NSW;
- · Royal Agricultural Society of Tasmania;
- · Royal National Capital Agricultural Society;
- · Royal Agricultural Society of WA; and
- any breed association or society recognised by Melbourne Royal.

**Business Day** means a week day on which banks in Melbourne are open for business.

**Chief Executive Officer** means a person occupying or acting in the position of Chief Executive Officer of Melbourne Royal.

**Chief Steward** means the person occupying or acting in the position of Chief Steward of a section.

**Closing Date** means the date and time set out in the Relevant Schedule after which entries for the Event will not be accepted by Melbourne Royal.

**Drug** has the meaning set out in the Relevant Schedule.

**Event** includes competition and class and without limitation includes any event listed in a Schedule. Event also includes the period of bump-in and bump-out for the Event and the period of the Event competition.

**Entry Form** means an entry form (or online equivalent) supplied by Melbourne Royal for an Event.

**Event Participant** includes judges, stewards, contractors, spectators, Exhibitors and all persons present at the Venue during the Event.

**Exhibit** means the animal, person or item entered into an Event by an Exhibitor.

**Exhibitor** means the owner of the Exhibit, and if the owner is less than 18 years of age, the parent or guardian of the owner who signs the Entry Form.

**Inspector** means a person described as such in the Regulations.

**Judge** means a person appointed by Melbourne Royal to judge an Event.

**Motor Vehicle** includes a truck, trailer, horse float and stock transporter but does not include a caravan.

**Melbourne Royal** means Melbourne Royal (ACN 006 728 785).

#### Regulations means:

- (a) Melbourne Royal's General Regulations For All Competitions;
- (b) the rules, regulations and conditions of entry set out in the Relevant Schedule; and
- (c) the rules, regulations and conditions of entry set out on the Entry Form for the Event.

**Relevant Schedule** means the Schedule which applies to the particular Event in which the Exhibitor has submitted or proposes to submit an entry in accordance with these Regulations.

**Review Committee** means a committee appointed under Regulation 12.4.

**Schedule** means a Schedule of events and prizes issued by Melbourne Royal and without limitation, a reference to a Schedule includes a reference to the rules, regulations and conditions set out in the Schedule.

**Show** means the Melbourne Royal Show.

**Showgrounds** means the Melbourne Showgrounds, Epsom Road, Ascot Vale, Victoria and includes without limitation all areas owned, used, rented or leased by Melbourne Royal.

**Steward** means a person occupying or acting in the position of steward.



**Venue** means the site or location at which the Event is held.

**Veterinary Surgeon** means a veterinary surgeon appointed by Melbourne Royal.

#### 1.2 INTERPRETATION

Headings are for convenience only and do not affect interpretation. The following rules apply unless the context requires otherwise.

- (a) The singular includes the plural and conversely.
- (b) A gender includes all genders.
- (c) If a word or phrase is defined, its other grammatical forms have a corresponding meaning.
- (d) A reference to a person, corporation, trust, partnership, unincorporated body or other entity includes any of them.
- (e) A reference to a Regulation is a reference to a Regulation of these Regulations.
- (f) A reference to a Regulation, rule or condition of entry is to the regulation, rule or condition of entry as amended, varied, supplemented, novated or replaced, except to the extent prohibited by these Regulations.
- (g) A reference to a right or obligation of any two or more persons confers that right, or imposes that obligation, as the case may be, jointly and severally.

In the event of an inconsistency between the Regulations and a Schedule, the Regulations prevail to the extent of the inconsistency unless otherwise provided.

#### 1.3 EXEMPTIONS

Melbourne Royal may, by notice in writing, exempt an Exhibit or an Exhibitor from one or more of the obligations or requirements contained in these Regulations.

#### 1.4 CONSENTS OR APPROVALS

Where the doing of any act, matter or thing under these Regulations is dependent upon the consent or approval of a person or is within the discretion of a person, the consent or approval may be given or discretion may be exercised conditionally or unconditionally or withheld by the person in its absolute discretion and without giving or assigning any reason for it.

#### 2. ENTRIES

#### 2.1 REQUIREMENTS FOR ENTERING AN EVENT

An entry to an Event must be:

(a) submitted on an Entry Form;

- (b) acknowledged by a physical signature or electronic authorisation by the Exhibitor or, if the Exhibitor is less than 18 years of age, acknowledged by the Exhibitor's parent or guardian;
- (c) fully paid for as set out in the Relevant Schedule:
- (d) submitted before the Closing Date to Melbourne Royal's Registered Office or electronic service; and
- (e) Any Exhibit entered into an Event must be disease free and in good health and condition.

#### 2.2 WARRANTY

The Exhibitor represents and warrants to Melbourne Royal that the information set out on the Entry Form is complete, accurate and not misleading in any way.

#### 2.3 RULES AND REGULATIONS

An entry is subject to the:

- (a) Regulations; and
- (b) Relevant Schedule.

#### 2.4 ENTRIES SUBJECT TO RULES AND REGULATIONS

Upon submission of an entry in accordance with Regulation 2, the Exhibitor agrees to be bound by the rules, regulations and conditions referred to in Regulation 2.2 and to ensure that each Agent of the Exhibitor complies with those rules, regulations and conditions. An act or omission of an Agent of an Exhibitor may be deemed by Melbourne Royal to be the act or omission of the Exhibitor.

#### 2.5 ALTERED ENTRIES

Subject to the discretion of Melbourne Royal an entry may not be altered after the Closing Date.

#### 2.6 NUMBER OF ENTRIES

Melbourne Royal may restrict the number of entries in any Event.

#### 2.7 LIMIT ON ENTRY INTO MULTIPLE ORDINARY CLASSES

Subject to the Relevant Schedule, an Exhibit must not be entered in more than one Ordinary Class. Should any Exhibit be sought to be entered in more than one Ordinary Class, the Exhibit will only compete in the Ordinary Class in which the Exhibit's or the Exhibitor's name first appears in Melbourne Royal's Catalogue unless Melbourne Royal otherwise directs. For the purposes of this Regulation, Sweepstakes, Special Classes, Trophy Classes and Championships are not an Ordinary Class. 'Ordinary Class', 'Sweepstakes', 'Special Class', 'Trophy Class' and 'Championship' have the meaning given in the Relevant Schedule.



#### 3. ENTRY AND NOMINATION FEES

- 3.1 The entry fee and, if applicable, the nomination fee, become the property of Melbourne Royal on receipt by Melbourne Royal and, without limitation, the entry fee and, if applicable, nomination fee paid in respect of an entry which is withdrawn, or which does not satisfy the requirements for entry or conditions of eligibility will not be refunded.
- or a competition/awards program is cancelled due to COVID-19 health regulations or if state borders restrictions are enforced and the Exhibitor is unable attend the Show, Melbourne Royal will provide a full refund on entry fees, pre-purchased onsite accommodation fees (lockers and camping), showgrounds parking fees, showgrounds stabling/bedding fees and pre-ordered catalogues. Melbourne Royal will not be liable for any other costs incurred. Melbourne Royal will provide a pro-rata refund of fees in the event that Show days are cancelled due to COVID-19.

### 4. DOCUMENTS FOR PRESENTATION WHILST AT THE SHOWGROUNDS

Animal Registration papers, AAR microchip papers, show-jumping performance cards and birth certificates, or certified photocopies thereof, are not required to be submitted to Melbourne Royal or to accompany an Application for Entry. Such documentation will be required to be on hand whilst the Exhibitor and the Exhibits are on the Showground (if the Application for Entry specifies such documentation is required) and must be produced upon request for perusal by the Chief Steward or other Melbourne Royal authorised person. Failure to produce such documents if requested will result in the Exhibit being ineligible for the Event.

#### 5. OWNERSHIP OF EXHIBITS

#### 5.1 OWNERSHIP ON ENTRY

At the time Melbourne Royal receives the Entry Form for entry to an Event; the Exhibit entered into that Event by the Exhibitor must be the property of the Exhibitor or held by the Exhibitor under a written lease in existence at that time.

#### 5.2 OWNERSHIP ON JUDGING

At the time of judging an Event, each Exhibit entered into that Event by an Exhibitor must be

the property of the Exhibitor or be held by the Exhibitor under a written lease in existence at that time. An Exhibit which is not the property of the Exhibitor or held by the Exhibitor under a written lease in existence at the time of judging will be ineligible for the Event.

#### 5.3 INELIGIBILITY FOR EVENT

An Exhibit which is not the property of the Exhibitor or held by the Exhibitor under a written lease in existence both at the time Melbourne Royal receives the Entry Form and at the time of judging will be ineligible for the Event.

#### 6. EXHIBITION OF EXHIBITS

#### 6.1 GROUNDS FOR NOT EXHIBITING AN ANIMAL

The Exhibitor must not withdraw an Exhibit from an Event, and an Exhibit must be exhibited, unless a certificate signed by a veterinary surgeon is lodged with Melbourne Royal certifying that the Exhibit is unable to compete for one or more of the following reasons:

- (a) the Exhibit, being an animal, has died;
- (b) the Exhibit, being an animal, is unfit to be exhibited due to injury or disease;
- (c) the Exhibit is ineligible for the Event; or
- (d) some other cause Melbourne Royal considers reasonable.

#### 6.2 TIME FOR WITHDRAWING AN ANIMAL EXHIBIT

A certificate given under Regulation 6 must be given to Melbourne Royal:

- (a) before the date for admission of the Exhibit to the Showgrounds (as set out in the Relevant Schedule), if the cause for withdrawal of the Exhibit occurs or arises before that date; or
- (b) otherwise, as soon as possible after the cause for withdrawal of the Exhibit occurs or arises.

#### 6.3 TRAINING OR PREPARING EXHIBITS OR EXHIBITORS

Exhibitors must not enter into an Event that is to be judged by a person who has trained or prepared the Exhibitor or Exhibit within six months of the date of the Event.

#### 7. EXHIBIT TICKET

Subject to the Relevant Schedule, Melbourne Royal will issue an exhibit ticket for an Exhibit unless it otherwise determines. The Exhibitor or an Agent must produce the exhibit ticket upon a request from Melbourne Royal or a Steward.



#### 8. CONDUCT OF EXHIBITORS AND AGENTS

#### 8.1 COMPLIANCE WITH RULES AND REGULATIONS

Where an Exhibit and/or Exhibitor and/or an Agent fail to comply with any of the Regulations, Melbourne Royal may impose one or more of the following penalties on the Exhibit or Exhibitor or both of them:

- (d) disqualification;
- (e) suspension;
- (f) a fine;
- (g) order the Exhibit or the Exhibitor, his or her family, invitees and Agents be removed from the Showgrounds; or
- (h) any other penalty.

Without limiting the above, Melbourne Royal may forfeit an award, and upon forfeiture, the Exhibitor must return any ribbon, money, prize card or other evidence of that award to Melbourne Royal within seven days after receiving notification of the forfeiture. Nothing in this Regulation limits Regulation 8.10.

#### 8.2 COMPLIANCE WITH DIRECTIONS

- (a) The Exhibitor and/or Agent must fully comply with the directions and requests of Melbourne Royal. Without limitation, directions and requests of Melbourne Royal may apply to the Exhibit, the Exhibitor, the Agent, the conditions of the Event, the conduct of the Exhibitor, the conduct of the Event, the conduct of the Agent, the decision of the Judge, or the award of prizes.
- (b) Without limiting Regulation 88.2, upon a request from Melbourne Royal, an Exhibitor and/or Agent must make a statutory declaration in the form and with respect to matters Melbourne Royal in its discretion requires.
- (c) Without limiting Regulation 88.2, upon a request from Melbourne Royal, an Exhibitor and/or Agent must submit his or her Exhibit for inspection by a Veterinary Surgeon.

#### 8.3 STATEMENTS

The Exhibitor and/or Agent must not make a statement regarding an Exhibit, which in the opinion of Melbourne Royal, is fraudulent, false, erroneous, misleading or deceptive or likely to mislead or deceive.

#### 8.4 TAMPERING

An Exhibit must not be or have been tampered with or otherwise improperly dealt with by an Exhibitor.

#### 8.5 UNACCEPTABLE BEHAVIOUR

Melbourne Royal is committed to providing a fair and equitable Venue for all participants, free from all forms of harassment, bullying and violence. The following behaviours will not be tolerated and may result in the event participant/Exhibitor being removed from the competition Venue and/or disqualified from the competition and formal procedures initiated:

- (a) violence;
- (b) bullying;
- (c) harassment;
- (d) sexual harassment;
- (e) unlawful discrimination;
- (f) victimisation.

Persons breaching acceptable standards of behaviour may be banned from entering future Melbourne Royal Events and/or the Venue.

#### 8.6 ANIMALS AND LIVESTOCK

Unless Melbourne Royal gives prior written approval, pets, animals or livestock other than Exhibits must not be brought onto or permitted to enter or remain on the Showgrounds.

#### 8.7 MUTUAL RECOGNITION

Melbourne Royal may recognise, act upon and enforce any penalty imposed by a Body on an Exhibit or Exhibitor or Agent at any time.

#### 8.8 FURTHER PROCEEDINGS

Melbourne Royal may conduct further proceedings in relation to any matter concerning an Exhibitor, an Exhibit, an Agent, a potential Exhibitor, or a potential Exhibit, and impose any suspension, fine, disqualification, withdrawal or forfeiture of an award, handicap, reprimand, warning or any other penalty, irrespective of whether a Body has already imposed a penalty on the Exhibitor or the Exhibit or Agent, or on the potential Exhibitor or the potential Exhibit.

#### 8.9 RECIPROCAL ARRANGEMENTS

Melbourne Royal may enter into reciprocal arrangements with a Body in relation to any matter concerning an Exhibit, an Exhibitor, an Agent, a potential Exhibit or a potential Exhibitor.

#### 8.10 SMOKING

Melbourne Showgrounds is a completely smokefree venue (effective 1 September 2016). Exhibitors, staff, patrons and contractors wanting to smoke will need to exit the venue to do so.



#### 9. POWERS OF MELBOURNE ROYAL IN RESPECT TO CONTROL OF THE EVENT

#### 9.1 POWER TO REFUSE TO ACCEPT AN ENTRY, EXHIBIT OR EXHIBITOR

Melbourne Royal may refuse to accept an entry for an Event, an Exhibit or an Exhibitor or any of them.

#### 9.2 POWER TO CANCEL OR ALTER

Melbourne Royal may:

- (a) alter the Closing Date for an Event, or the Closing Date for receipt of any particular entry;
- (b) remove any Exhibit from the Showgrounds or cause any Exhibit to be removed from the Showgrounds;
- (c) amend an entry for an Event to, without limitation, substitute an alternate competition or class for the competition or class in which the Exhibit is or was entered:
- (d) alter the conditions of any Event;
- (e) refuse to display an Exhibit;
- (f) rule that an Exhibit or Exhibitor may not compete or is ineligible to compete;
- (g) alter the date, time or place on or at which any Event is scheduled to take place or to be judged;
- (h) alter the Judge scheduled to judge any Event; or
- (i) cancel any Event.

The rights set out above apply notwithstanding:

- (a) Melbourne Royal's acceptance of an entry for an Event;
- (b) inclusion of an entry for an Event in the Event Catalogue;
- (c) the issue of an exhibit ticket to an Exhibitor or in respect of an Exhibit or an Event; or
- (d) the issue of any other document to an Exhibitor or in respect of an Exhibit or an Event.

#### 10. ILLNESS OF AN ANIMAL

#### 10.1 ANIMAL HEALTH STATUS

If the Exhibitor or any Agent of the Exhibitor detects or suspects any illness amongst any of their Exhibits whilst the Exhibits are at the Showgrounds, the Exhibitor must:

- (a) report this fact immediately to the representative of Melbourne Royal responsible for the applicable livestock section (the Superintendent);
- (b) ensure that the Exhibit(s) concerned is/ are contained within the space allocated by Melbourne Royal for the Exhibit(s), unless advised otherwise by the Superintendent or a member of Melbourne Royal veterinary panel on duty; and

(c) where feasible to do so, contain soiled bedding from the Exhibit(s) concerned within the space allocated by Melbourne Royal for the Exhibit(s).

The Exhibitor may engage or consult a private veterinary surgeon in respect to the illness only after the above action has been taken and only after first consulting with a member of Melbourne Royal veterinary panel on duty.

#### 10.2 TREATMENT UPON ILLNESS OR INJURY

If an Exhibit is ill or injured, a Veterinary Surgeon may in his or her discretion attend to or treat the Exhibit. The Veterinary Surgeon may do so even in the absence of authority from the Exhibitor, or contrary to that authority.

#### 10.3 DESTRUCTION OR REMOVAL

Where, in the opinion of a Veterinary Surgeon, an Exhibit should be destroyed or removed from the Showgrounds:

- (d) the Veterinary Surgeon or any other person approved by Melbourne Royal may destroy or remove the Exhibit from the Showgrounds, or both; or
- (e) Melbourne Royal may require the Exhibitor to immediately destroy or remove the Exhibit from the Showgrounds or both.

All costs and expenses incurred by Melbourne Royal pursuant to this Regulation must be reimbursed by the Exhibitor to Melbourne Royal. Nothing in this Regulation limits Regulation 0.

#### 10.4 NECROPSY

If an Exhibit dies while at an Event, Melbourne Royal may require that a necropsy be conducted on the animal. The Exhibitor must allow for the immediate release of the body to Melbourne Royal if requested by Melbourne Royal.

#### 10.5 VETERINARY SURGEONS

Where an Exhibitor wishes to engage or consult a veterinary surgeon who is not appointed by Melbourne Royal, the Exhibitor must first inform the representative of Melbourne Royal responsible for the applicable livestock section. A Veterinary Surgeon, a Judge and Melbourne Royal itself is not required to have regard to or to consider any opinion of a veterinary surgeon so engaged or consulted by the Exhibitor, and a decision of a Veterinary Surgeon, a Judge or Melbourne Royal is final regardless of whether or not the Exhibitor has engaged or consulted a veterinary surgeon not appointed by Melbourne Royal.



#### 11. JUDGING

#### 11.1 INTERFERENCE

The Exhibitor and Agents of the Exhibitor must not consult, influence or interfere with a Judge or attempt to consult, influence or interfere with a Judge or do any other thing which may influence or interfere with the Judge's freedom of choice or judgment unless it is expressly authorised by the Relevant Schedule.

Unless with the permission of Melbourne Royal, no Exhibitor or Agent of an Exhibitor may occupy the position of Judge or become in any way identified with the judging or handling of Exhibits in any class in which that person or that person's employers, family members or associates are interested. This does not apply to Stewards.

#### 11.2 INDICATIONS OF OWNERSHIP

The Exhibitor, any Agent of the Exhibitor and the Exhibit must not be equipped with or wear or display anything indicating the ownership of the Exhibit before or during judgment of the Exhibit unless it is expressly authorised by the Relevant Schedule.

#### 11.3 DECISION

Except as otherwise expressly provided in the Regulations, the decision of a Judge as to the merits of the Exhibit and the Exhibitor or either of them will be final, and the Exhibitor may not protest or appeal the decision.

#### 11.4 PRIZES

Subject to the Relevant Schedule, a Judge may in his or her opinion:

- (a) award a second or third prize in place of a first prize:
- (b) withhold a prize where a prize should not be awarded;
- (c) where there is a tie for any placing in an Event, award subsequent placings so that the next placing will be the number of Exhibits already placed plus one (for example, if two Exhibits tie for first place, award a third for the next placing);
- (d) where all the prizes offered in an Event have been awarded and a further Exhibit is of sufficient merit to deserve a prize make a reserve number of the further Exhibit; or
- (e) give commendations where they are deserved.
- (f) award an Exhibitor more than one prize in any class where more than one entry is permitted.

#### 11.5 DISQUALIFICATIONS

Where an Exhibit or an Exhibitor is disqualified and the applicable award is forfeited, Melbourne Royal may (but is not obliged to) promote the Exhibit next in order to that prize, whether the Exhibit next in order was awarded a prize or a reserve number. Exhibits next in order, whether awarded a prize or reserve number, may also be promoted to the prize next in order.

#### 11.6 PRIZE CARDS

The Exhibitor must ensure that prize cards awarded for an Exhibit are displayed with the Exhibit while it is on exhibition.

#### 11.7 JUDGING/STEWARDING COVID HEALTH REGULATIONS

Melbourne Royal will not reimburse any costs (accommodation, meals, loss of income etc) incurred by judges, stewards or other event participants due to enforced COVID-19 isolation and/or quarantine.

Please note, some judging positions may need to be changed without notification to Exhibitors. Melbourne Royal retains the right to fill a judging position at its own discretion in the event a judge is unable to participate for any reason, including COVID-19 or any travel related restrictions.

#### 12. PROTESTS AND APPEALS

#### 12.1 RESTRICTED TO CLASS

Protests and appeals may only be made by Exhibitors with Exhibits in the class to which the protest relates.

#### 12.2 PROTEST TO STEWARDS

The Exhibitor may protest to the Chief Steward of the relevant section in relation to conduct, judging or any other matter relating to an Event. A protest must be made in accordance with the procedures set out in the Relevant Schedule and be received by the Chief Steward within 24 hours after the conclusion of the applicable Event.

#### 12.3 APPEAL

The Exhibitor may appeal against:

- (a) a decision made by Melbourne Royal pursuant to Regulations; or
- (b) a decision of the Chief Steward or if the Chief Steward delegates the person to make the decision to the Assistant Chief Steward, the decision of the Assistant Chief Steward in relation to a protest under Regulation 12.



#### 12.4 FORM OF APPEAL

To be an appeal for the purpose of Regulation 12.2 an appeal made by the Exhibitor must be:

- (a) in writing setting out in reasonable detail the grounds for the appeal;
- (b) addressed to:
   The Chief Executive Officer
   Melbourne Royal Limited
   Melbourne Showgrounds
   Epsom Road, Ascot Vale, Victoria, 3032;
- (c) accompanied by a deposit of \$200.00 (or such other amount as is notified from time to time by Melbourne Royal for the purpose of this Regulation 12.3(c)); and
- (d) received by the Chief Executive Officer by 5 p.m. on the Business Day which is 10 Business Days after the day on which the decision the subject of the appeal was made.

#### 12.5 REVIEW COMMITTEE

If an appeal is made in accordance with Regulation 12.3, the Chief Executive Officer must appoint a Review Committee comprised of three people, being persons who were not part of, and who are independent of, the committee or personnel who made the decision the subject of the appeal.

Within a reasonable time after receipt by the Chief Executive Officer of an appeal complying with Regulation 12.3, the Review Committee will meet to consider the appeal.

#### 12.6 PROCEEDINGS OF THE REVIEW COMMITTEE

In considering an appeal, the Review Committee

- (a) give due consideration to the grounds of appeal submitted by the Exhibitor, and to any other evidence submitted by the Exhibitor;
- (b) give the Exhibitor an opportunity to make oral representations to the Review Committee; and
- (c) in its discretion, call for and hear expert opinion.

#### 12.7 NOTIFICATION OF REVIEW COMMITTEE'S DECISION

The Chief Executive Officer will notify the Exhibitor of the Review Committee's decision within 48 hours after that decision is notified by the Review Committee to the Chief Executive Officer. The decision of the Review Committee is final and the Exhibitor will not have any right of appeal in respect of the Review Committee's decision.

#### 12.8 FORFEITURE OF DEPOSIT

Where an appeal is upheld by the Review Committee, the deposit referred to in Regulation 12.3 will be refunded to the Exhibitor when or within a reasonable time after the decision of the Review Committee is notified by the Chief Executive Officer to the Exhibitor. Where an appeal is not upheld by the Review Committee, the deposit referred to in Regulation 12.3 will be retained by Melbourne Royal.

#### 13. ACCOMMODATION

#### 13.1 NO OBLIGATION TO PROVIDE EXHIBIT SPACE OR ACCOMMODATION

- (a) Melbourne Royal is not obliged to provide space for an Exhibit or accommodation for an Exhibitor or any Agent of an Exhibitor.
   For the purposes of these Regulations, "accommodation" includes provision of a space for a person to sleep.
- (b) Where Melbourne Royal, in its discretion, allocates space for an Exhibit or accommodation for an Exhibitor or any Agent of an Exhibitor, only the allocated areas may be used, and only for the purpose designated by Melbourne Royal.

#### 13.2 PERSONAL EFFECTS

Melbourne Royal has no responsibility or liability for any loss or damage:

- (a) suffered by an Exhibitor or any Agent of an Exhibitor using space provided for an Exhibit or accommodation for an Exhibitor or any Agent of an Exhibitor; or
- (b) caused to personal belongings, equipment or property which is brought onto the Showgrounds by an Exhibitor or any Agent of an Exhibitor.

#### 14. FIRE REGULATIONS

#### 14.1 FLAMES

The Exhibitor and any Agent of the Exhibitor must not smoke, cook, or heat water by any means whatsoever or use any device involving naked flame in or near any animal pavilion, stall, pen or locker.



#### 14.2 ELECTRICAL INTERFERENCE

The Exhibitor and any Agent of the Exhibitor must not:

- (a) subject to Regulation 14.2, use mains powered electrical devices in or near any animal pavilion, stall, pen or locker or any Exhibit.
- (b) alter or interfere with any electrical wiring, switch, plug or socket whatsoever on the Showgrounds.

#### 14.3 EXCEPTIONS

Nothing in Regulation 14(a) prohibits the use of main powered electrical appliances which are, in the opinion of Melbourne Royal, essential to animal care, or the use of a light-bulb in a locker if the light-bulb is fitted in the socket provided.

#### 15. VEHICLE PARKING

#### 15.1 LOADING AND UNLOADING

With the prior consent of Melbourne Royal, Motor Vehicles of an Exhibitor or an Agent of an Exhibitor may enter the Showgrounds or any area under Melbourne Royal control, for the purpose of loading or unloading only. Motor Vehicles must not remain on the Showgrounds, or any area under Melbourne Royal control, and must be removed immediately upon completion of loading or unloading.

#### 15.2 CARAVANS

Caravans of an Exhibitor or an Agent of an Exhibitor must not enter or remain on the Showgrounds, or any area under Melbourne Royal control, for any purpose, unless in accordance with the prior written consent of Melbourne Royal.

#### **15.3 TOW AWAY**

Any Motor Vehicle or Caravan entering or remaining on the Showgrounds, or any area under Melbourne Royal control, in contravention of the Regulations or of any other parking rules or restrictions, may be removed from the Showgrounds, or any area under Melbourne Royal control, by Melbourne Royal and stored. Any costs incurred by Melbourne Royal pursuant to this Regulation must be paid by the Exhibitor.

#### 16. LIABILITY AND INDEMNITY

#### 16.1 RELEASE

Entry to, remaining on and using the Showgrounds or any part of them by an Exhibitor is entirely at the risk of the Exhibitor and, to the maximum extent permitted by law, the Exhibitor releases Melbourne Royal (which term includes in this clause Melbourne Royal's officers, employees, members, contractors and agents), from all claims, demands and liabilities of every kind resulting from any accident, damage, injury or illness occurring at the Showgrounds and, without limitation, the Exhibitor acknowledges and agrees:

- (a) Melbourne Royal has no responsibility or liability for any loss, damage, injury or illness to or caused by any Exhibit;
- (b) Melbourne Royal has no responsibility or liability for any loss, damage, injury or illness to or caused by any Exhibitor or any Agent;
- (c) Melbourne Royal has no responsibility or liability for any loss or damage to a Motor Vehicle or any of its contents whilst it is on the Showgrounds or in any car park under Melbourne Royal's control; and
- (d) without limiting Regulations 16(a) and 16(b) above, Melbourne Royal has no responsibility or liability for any loss, damage, injury or illness resulting from the sale, treatment, failure to treat, destruction, disposal or other dealing with any Exhibit, or for any loss, damage or injury to any personal belongings, equipment or property brought onto the Showgrounds by any person.

#### 16.2 INDEMNITY

To the maximum extent permitted by law, the Exhibitor indemnifies and keeps indemnified Melbourne Royal and its officers, employees, members, contractors and agents from and against all actions, claims, demands, losses, damages, costs, expenses and liabilities including without limitation, consequential loss and loss of profits for which Melbourne Royal is or may be or become liable in respect of or arising from:

- (a) loss, damage, injury or illness to any person in connection with the Exhibit or the relevant Event;
- (b) without limiting Regulation 16(a), loss, damage, injury or illness to any other Exhibit or Exhibitor, or any Agent of any other Exhibitor, or to the property of Melbourne Royal, or its members, or to the general public, or any member of the general public, caused or contributed to or by any act or omission of an Exhibit of the Exhibitor or by the Exhibitor or any Agent of the Exhibitor; and



(c) without limiting Regulation 16(a), loss, damage, injury or illness to the Exhibit, or to the Exhibitor or any Agent of any other Exhibitor caused or contributed to by an act or omission of an Exhibit or by the transportation, feeding, housing or exhibiting of an Exhibit.

#### 16.3 REMOVAL FROM SHOWGROUNDS

Without prejudice to any other provision in these Regulations, where Melbourne Royal, its officers, employees, members, contractors or agents removes an Exhibit, or causes an Exhibit to be removed from the Showgrounds, the Exhibit is removed or caused to be removed entirely at the risk of the Exhibitor. The person or persons removing the Exhibit will be deemed to be the agent of the Exhibitor, and his or her acts and omissions will be deemed to be the acts and omissions of the Exhibitor.

#### 17. ANIMAL OWNER'S LIABILITY INSURANCE

Melbourne Royal may arrange owner's liability insurance cover for Exhibitors of Exhibits that are animals, and, if Melbourne Royal does so, the Exhibitor is bound by the terms and conditions of this insurance and by applicable duties of an insured under the Insurance Contracts Act (1984). Details of owner's liability insurance cover arranged by Melbourne Royal are set out in the Relevant Schedule.

#### 18. INFORMATION HANDLING

Melbourne Royal is bound by the National Privacy Principles of the **Privacy Act 1988** (Cth) and other applicable laws governing privacy.

#### 18.1 COLLECTION OF PERSONAL INFORMATION

- (a) Melbourne Royal may collect, hold and use personal information about Exhibitors, their family members, invitees or Agents.
- (b) The types of information that may be collected include names and contact details, credit card details, qualifications, results of the Exhibitor's entry into the relevant Event and any reprimand, fine, disqualification, withdrawal of an award or penalty imposed on the Exhibitor in connection with entry of the Exhibit in the relevant Event. Information may also be collected from other Bodies relating to the Exhibitor's entry into events held by that Body including, without limitation, reprimands, fines, disqualifications, withdrawals of awards or penalties imposed.

- (c) Personal information is collected for the purpose of administration of Events and the Show, as well as related purposes including, without limitation, promoting the Events and the Show, maintenance of records of information relevant to qualifications for future events, maintenance of health and safety records in relation to Events, applicable insurance cover for Events and making claims under Melbourne Royal's insurance for incidents which involve an Exhibitor and occur during an Event.
- (d) Personal information may also be used for the purpose of informing Exhibitors about other events and services. Melbourne Royal may send an Exhibitor publications and information about other events and services unless the exhibitor indicates to Melbourne Royal that the Exhibitor does not want to receive such publications or information.

#### 18.2 SHARING OF PERSONAL INFORMATION

- (a) Melbourne Royal may share information which has been collected by Melbourne Royal under Regulation 0 with other organisations and service providers to assist in administering the Events and the Show, including co-sponsors of Events and health service providers, indemnity or insurance providers or other Bodies, or any entity that may subsequently administer the Event
- (b) Melbourne Royal may also publish winners details on its websites or publications or disclose information about an Exhibitor to the media for the purpose of publishing articles on the Exhibitor's participation in the Event, unless the Exhibitor has requested that the Exhibitor's personal information not be published or disclosed for these purposes.
- (c) Melbourne Royal may also disclose information if otherwise required or authorised by law.

#### 19. COVID SAFE SHOW

Melbourne Royal will work closely with DHHS to ensure that the Melbourne Royal Show is compliant with all COVID Safe requirements as directed by Government and to optimise the safety for all patrons, Exhibitors, staff and competitors.
