CEO's Message

After two years of COVID disruptions, we pleasingly returned to delivering on our purpose – to celebrate agriculture, cultivate events and strengthen communities during 2022/23.

Our 2022/23 financial year was one of the most successful years on record for Melbourne Royal with the Show, Venue and Awards Programs all delivering outstanding outcomes.

2022 Melbourne Royal Show

The Melbourne Royal Show is the Victorian major event that brings the community together to celebrate agriculture – producers, products and produce – from rural and regional Victoria to greater Melbourne, it's for all Victorians.

After the two-year hiatus due to the COVID pandemic, the Melbourne Royal Show, Victoria's most iconic community event, returned bigger and better than ever in 2022. Visitors to the 2022 Show enjoyed the great family fun and farm experiences by day and the feast of fabulous food, spectacular entertainment and live music by night.

Held over 11 days from Thursday 22 September to Sunday 2 October, the 2022 Melbourne Royal Show proudly saw 501,784 people attend, the highest attendance for 15 years.

For the first time this year, the number of tickets available for sale each day was capped at 50,000. The self-imposed limit on ticket sales was implemented to provide the best possible visitor experience and improve the visitor flow around the site.

The Victorian Government's support to provide free admission for children 14 years and under was an incredible success and greatly contributed to the increased attendance, with almost 180,000 child tickets redeemed.

Thank you to the Victorian community for supporting the event by attending, and everyone involved in the making the 2022 Melbourne Royal Show better than ever in particular:

- Melbourne Royal Competition Section Committees for their tireless work, commitment, passion and enthusiasm to maximize the appeal and success of their respective competitions.
- The 1100 plus volunteers who assisted us deliver the event, involved a variety of roles from judges, stewards and customer service
- Competitors and exhibitors for taking part in the Show and congratulations to all those who won a coveted Melbourne Royal blue ribbon
- Melbourne Royal members, and pleasingly we welcomed a significant number of new members this year. I trust those who chose to be members enjoyed great value and benefit from being a member.

501,784 people attended the 2022 Melbourne Royal Show – the highest attendance for 15 years.

- Carnival operators, showbag retailers, food vendors and retail exhibitors
- Hundreds of casual staff and more than 900 business were involved in some way with the 2022 Show including suppliers and service providers.

Considerable thought, planning and effort went into delivering the 2022 Show after a two-year hiatus and I am incredibly proud of the Melbourne Royal team for their commitment, energy and enthusiasm to ensure the Show returned better than ever in 2022.

Our Venue – Melbourne Showgrounds

It was also an outstanding year for our Venue business with record revenue generated from more than 120 external events held at Melbourne Showgrounds during the year. There were several significant 'one-off' client activations that contributed to the record revenue generated from venue hire including the Victorian Electoral Commission for the 2022 State Election vote count; Equitana, a bi-annual horse show; and we held two Caravan and Camping Supershows during our 2022/23 financial year.















CEO's Message

It was pleasing to see the return of large-scale annual event clients, despite the ongoing need to operate as a COVID testing centre at Melbourne Showgrounds until September including but not limited to MotorEx, Outdoor 4x4 Show, Meatstock, and SupaNova along with MasterChef which continued to be produced onsite. In addition, we were delighted to see the return of music festivals at Melbourne Showgrounds including Pure Carl Cox; Above & Beyond **Group Therapy Weekender** and Palm Tree Music Festival headlined by Tiesto.

Bookings and utilization of the Victoria Pavilion as a banquet space improved as industry confidence grew throughout the year. The Victoria Pavilion was the venue of choice for a number of functions and events including the Western United End of Season Awards dinner, Country Women's Association AGM and Conference, St Bernard's Valedictory, North Melbourne Football Club Syd Barker Medal, Harness Racing Awards and the Premier's Diwali State Reception.

The State's largest and most efficient COVID testing facility at Melbourne Showgrounds finally closed in September 2022. The COVID testing facility was onsite for a remarkable 115 weeks and I thank the Department of Health and Western Health for collaborating with us to provide this important community service at Melbourne Showgrounds.

Melbourne Royal has fabulous partners, service providers and suppliers that assist us to deliver successful events at Melbourne Showgrounds. I particularly thank and acknowledge Encore Event Technologies and Moonee Valley Racing Club's catering group, Dean & McPherson. Both venue partners have contributed significantly to assisting Melbourne Royal elevating our venue offering and experience.

I thank Directors on the Showgrounds Nominees Board, Unincorporated Joint Venture between the Melbourne Royal and the State Government of Victoria for their support along with our venue facility managers, BGIS for their ongoing assistance and cooperation in working collaboratively with the Melbourne Royal team.

Our Awards Programs – Agriculture, Food & Beverages

During the 2022/23 financial year, we judged and presented medals and trophies in all four Melbourne Royal beverage awards – Beer, Wine, Coffee and Distilled Spirits. Each were an outstanding success, particularly the Australian International Beer Awards and the Australian Distilled Spirits Awards.

The Australian Distilled Spirits Awards also attracted a record 863 entries and more than 350 guests attended the trophy presentation cocktail evening held in the Victoria Pavilion at Melbourne Showgrounds in November 2022.

The Australian International Beer Awards attracted record 2634 entries and a record 900 plus guests attended the trophy presentation dinner held in the Victoria Pavilion at Melbourne Showgrounds in May 2022.

Overall, we received more than 6566 entries across our four beverage awards programs, which was remarkable considering the ongoing supply chain issues and resourcing challenges experienced by these respective sectors.

I sincerely thank our respective Industry Advisory Groups and Wine Committee for their involvement, counsel and support in assisting us maximise the appeal and success of each of these awards.

2022 Melbourne Royal *Show*

The Melbourne Royal Show returned bigger and better than ever in 2022!

Our 2022/23 financial year was one of the most successful years on record for Melbourne Royal with the Show, Venue and Awards Programs all delivering outstanding outcomes.

Victoria's most loved and iconic community event, the Melbourne Royal Show, returned in 2022 better than ever with more smiles and bigger attendances!

Over the 11 days of the 2022 Melbourne Royal Show, from Thursday 22 September to Sunday 2 October, we saw:

- 501,784 people come through the gates across 11 days, the highest attendance for 15 years
- More than 50,000 attend each of the first four days
- The first day, Thursday 22
 September was a sell-out and a record Day 1 attendance
- Sunday 25 September was also a sell-out
- On eight of the 11 days, more than 40,000 people attended, including the final day, Sunday 1 October.

Visitors to the 2022 Show loved the great family fun and farm experiences by day and the feast of fabulous food, spectacular entertainment and live music by night. The new and improved layout and the addition of new food precincts, including Melbourne Laneway and Graze open-air dining with ample seating, were a huge success.

The Victorian Government support of children 14 years and under being admitted free was a huge success and contributed to the increased attendance, with more than 179,000 child tickets redeemed.

Melbourne Royal CEO Brad Jenkins said: "After the two-year hiatus it was incredibly pleasing to see half-a-million people come along and enjoy a great day and night out with family and friends at the 2022 Melbourne Royal Show.

The true stars of the Show were the thousands of animals and their handlers all vying to win a coveted Melbourne Royal blue ribbon. From livestock and their handlers to show horses and their champion riders; poultry and their fanciers and the championship dogs and their owners.

Over 3,000 of the most intricate creations of the art, craft and cookery entrants were on display, along with the strength and skill of the woodchoppers, all striving to claim a Melbourne Royal blue ribbon.

A record breaking 16,027 scones were baked and sold, with jam and cream added, by the Country Women's Association (CWA).

The Show After Dark also saw increased evening attendances, with the most popular nights being Friday 23 September with The Veronicas, Friday 30 September with Sneaky Sound System and Saturday 1 October with Baker Boy.

The Melbourne Royal Show is a much-loved Victorian major event that puts smiles on faces and brings the community together to celebrate agriculture. We are most grateful to the Victorian community for supporting the 2022 Melbourne Royal Show and making it better than ever.

With over 1,100 volunteers and 900 businesses involved in bringing the Show to life, the Melbourne Royal Show contributed over a quarter of a billion dollars to the state economy.



2022 Melbourne Royal Australian *Distilled Spirits* **Awards**

Established by Melbourne Royal in 2015, the Australian Distilled Spirits Awards is the first and largest national awards program, recognising excellence in Australian distilled spirits and liqueurs.

In 2022, the Australian Distilled Spirits Awards attracted 863 entries across 11 categories from 208 exhibitors, with a record number of entries in the Whisky and Gin classes. The Australian Distilled Spirits Awards awarded 75 gold, 382 silver and 311 bronze medals to distilleries from across Australia.

Melbourne Royal announced the trophy winners of the 2022 Australian Distilled Spirits Awards at an impressive cocktail awards presentation held on Wednesday 26 October in Victoria Pavilion at Melbourne Showgrounds.

Sixteen trophies were presented, with McLaren Vale's Never Never Distilling Co. awarded Champion Australian Distiller for the third year in a row. The distillery also won Best New World/Contemporary Gin for their Southern Strength Gin.

Victorian distillers took home almost a third of the top gongs, including Yack Creek Distillery, who won the Champion Victorian Distiller. Eltham's Naught Distilling took out Champion Victorian Gin with their Naught Sangiovese Gin.

Backwoods Distilling Co, family owned and operated in Yackandandah, won the Best Single Malt Whisky for their White Oak Expression.

Rye based Penni Ave Distillery won Best Vodka with their Wattle Seed and Burnt Honey Vodka, distilled with Pure Peninsula Orange Blossom honey and roasted native wattle seed.

Best Liqueur went to Kilderkin Distillery in Mount Pleasant for their Larrikin Bramble and Apple Pie Gin Liqueur.

The South Australian winners continued with St. Agnes Distillery winning Best Brandy with St Agnes XO, a 15-year-old brandy with aromas of stone fruits and citrus.

Fleurieu Distillery in South Australia took home the Best Grain or Blended Whisky for their Country to Coast 3.

Ginny Pig Distillery based in Tooperang, South Australia won the Best London Dry Gin for their Botanic Gin. Husband and wife team, Bec and Craig, run the distillery on their own property. Last year, they were awarded a Gold Medal for their London Dry Gin. Recognising the long tradition of distilling in Australia and the emergence of a new generation of spirits and liqueur producers, the Australian Distilled Spirits Awards provides Australian distillers with a valuable benchmarking opportunity to drive innovation and improve quality.

NSW distillers took home three awards, including Camden Valley Distilling Company for Best Other Gin with their Camden Valley Sloe Gin.

Regal Rogue in New South Wales won Best Vermouth for their Lively White, Semi-Dry, giving notes of elderflower, lemongrass, grapefruit and chamomile.

Best Bitter went to Inspirited in New South Wales for their Convicted Aromatic Bitters, handcrafted using native Australian botanicals.









Western Australian distillers picked up two awards, including Great Southern Distilling Company in Robinson, winning the Best Navy Gin with their Giniversity Southern Ocean Gin, with botanicals juniper, spinach and citrus being present.

The Packing Shed Distilling Co. in Western Australia won the Best Alternative Spirit with their Limoncello, made with locally grown lemons, combined with lemon myrtle, to give the perfect Australian twist.

Bundaberg Distilling Company in Queensland won the Raymond B 'Spike' Dessert III Trophy for Best Rum with their Bundaberg Rum: Master Distiller's Collection-Small Batch Reserve.

2022 Melbourne Royal *Wine* **Awards**

Conducted by Melbourne Royal since 1884, the Melbourne Royal Wine Awards provide producers with a valuable opportunity to benchmark their wines against industry standards, seek advice from an independent panel of experts, and promote and market award-winning products using the Melbourne Royal seal of excellence.

In 2022, the Awards received 2,360 entries from 380 wineries representing 67 wine regions across Australia. The judges awarded an amazing 172 gold, 259 silver and 662 bronze medals to wineries throughout Australia.

The winners of the 2022 Melbourne Royal Wine Awards were announced at the Trophy Presentation Dinner in Victoria Pavilion at Melbourne Showgrounds on Thursday 27 October 2022.

The Barossa Valley's Hentley Farm Wines was awarded the coveted Jimmy Watson Memorial Trophy for Best Young Red Wine, first awarded 60 years ago in 1962, for their 'The Old Legend', 2021 Grenache. This is the first time the 25-year-old Hentley Farm Wines have been awarded the Jimmy Watson Memorial Trophy.

In another coup for South Australia, the François de Castella Trophy for Best Young White Wine went to Adelaide Hill's Longview Vineyard for their 'Macclesfield' Grüner Veltliner 2022. This is the first time in a significant number of years that 'The Francois' has gone to a variety other than Chardonnay.

Longview Vineyard's 'Macclesfield' Grüner Veltliner also won Best Single Varietal White Wine, as well as Best Pinot Gris/Grigio for its 'Queenie' Pinot Grigio 2022, and Best Cabernet Sauvignon for its 'Devil's Elbow' Cabernet Sauvignon 2021. The growing prestige and reputation of the Australian Distilled Spirits Awards is testament to the value distillers place in being able to benchmark their spirits, liqueurs and bitters against their peers. The valuable feedback distillers receive from judges inspires innovation and product development.

The Champion Victorian Winery Trophy was awarded to Yarra Valley's Oakridge Wines, and Geelong's Scotchmans Hill was awarded The Trevor Mast Trophy for Best Shiraz for its 2021 Shiraz. This wine was also awarded Best Victorian Shiraz.

The Douglas Seabrook Trophy for Best Single Vineyard Wine went to 'Black Label Emerald Syrah' 2021 from Tasmania's Gala Estate. This wine also took out Best Tasmanian Shiraz, and the viticultural team at Gala Estate was also awarded The Kym Ludvigsen Trophy for Viticultural Excellence.

Tasmanian wineries continued to garner major award wins with the Dr Tony Jordan Trophy for Best Sparkling going to House of Arras Grand Vintage for its 2014 Chardonnay. For the seventh consecutive year, the James Halliday Trophy for Best Pinot Noir has gone to a Tasmanian winery.

This year, Lowestoft Estate Wines was once again awarded for their 'La Maison' Pinot Noir 2021, winning the award for the second year in a row.

2022 Melbourne Royal Australian International Beer Awards

The Melbourne Royal Australian International Beer Awards celebrates and recognises the best brewers across the world with up to 35 trophies presented to the champions of each category, including the overall Champion Australian Beer and Champion International Beer. These awards are the largest annual beer competition in the world, assessing both draught and packaged beer.

In 2022, the Awards attracted a record-breaking 2630 entries from 355 breweries in 20 countries.

Melbourne Royal announced the trophy winners for the 2022 Australian International Beer Awards at a sell-out presentation dinner in the spectacular Victoria Pavilion at Melbourne Showgrounds, with more than 900 guests from the beer and brewing industry in attendance.

Western Australia's Beerland Brewing was awarded the prestigious title of Champion Australian Beer for their Beerland Blueberry Clouds.

Champion Australian-Style Lager went to King Road Brewing Co, Western Australia for its King Road Lager.

Presented by Danielle Green MP, Parliamentary Secretary for Regional Victoria, Champion Victorian Brewery was awarded to Reservoir's Hawkers Beer, who also snapped up Champion Large Australian Brewery.

Also among Victorian winners were Dollar Bill Brewing who took out Australian Gypsy Brewer Award after last year winning the major Champion Australian Beer award. Collingwood's Stomping Ground Brewing Co. took out Champion Medium Australian Brewery.

The Champion International Beer went to Belching Beaver Brewery, CA, United States for its Viva La Beaver Stout.

Melbourne Royal was honoured for its innovative and highly successful **Australian International** Beer Awards event when it took out the Corporate Event of the Year at the Victorian Meetings and **Events Australia (MEA)** Awards night held in May 2023.

More international winners included Deep Creek Brewing Co, Auckland, New Zealand who won Champion Medium International Brewery; Bayerische Staatsbrauerei Weihenstephan, Bavaria, Germany for Champion Large International Brewery; Artmonster Brewery, Gyeonggi-do, Korea took out Champion Small International Brewery and The Bold Mariner Brewing Co, Virginia, United States snapped up the Gary Sheppard Memorial Trophy for the Best New Exhibitor.


























2022 Australian *International* **Coffee Awards**

The Australian International Coffee Awards provide coffee roasters with the unparalleled opportunity to have their products professionally critiqued, as well as the chance to establish their credentials in the Australian and international coffee industry.

In 2022, the Australian International Coffee Awards received 709 entries from 174 exhibitors representing 11 countries. Judging took place at Melbourne Showgrounds with a dedicated and talented team of 22 judges, 10 baristas and 18 stewards that brought the Awards to life over three days of judging.

Winners were announced online via the Melbourne Royal Facebook, Instagram and the Melbourne Royal official website.

New South Wales' Campos Coffee was awarded the prestigious title of Champion Australian Roaster, whilst also snapping up Best Immersion Coffee, Single Origin for their Colombia Santa Monica.

Composition

Performance and Culture Board Sub-Committee



Principal activities

The principal activities of the Company comprise organising and staging the Melbourne Royal Show and other agriculture, food, wine and related competitions, and also the venue management of the Melbourne Showgrounds. There were no significant changes in the nature of these activities during the year.

Objectives and strategies for achieving objectives

The objectives of the Company are to promote the development of all phases of the agricultural, pastoral, horticultural, viticultural, stock raising, manufacturing and industrial resources of Victoria.

The short-term objectives of the Company are to promote and celebrate agriculture through events that link industry to consumers and aim to improve quality and increase demand for Victorian agricultural produce.

The long-term objectives are to ensure financial sustainability of the Company whilst allowing for the enhancement of existing events, the development of new initiatives and further investing in the Melbourne Showgrounds site.

The Company's strategy for achieving these objectives is to hold, promote, assist or subsidise exhibitions, displays or shows of any nature or kind at any time or place. This includes conducting Victoria's largest community event, the Melbourne Royal Show, and leading industry events such as the Melbourne Royal Wine Awards, the Melbourne Royal Australian International Beer Awards, the Melbourne Royal Australian Distilled Spirits Awards, the Melbourne Royal Australian International Coffee Awards and the Melbourne Royal Australian Food Awards. In addition, the Company is also responsible for management of the Melbourne Showgrounds event and exhibition venue.

Performance measures

The objectives of the Company are able to be measured using various performance measures. These include numbers of members and exhibitors, event attendances, customer satisfaction ratings, number of agricultural industry organisations involved in events and competitions, and growth in returns from the Show, the venue and other events.

Review and results of operations

The 2022 Melbourne Royal Show was held over 11 days with total attendance exceeding 500,000, the highest attendance for 15 years. Two days were a sell-out with a record Day 1 attendance. The After Dark program continues to be successful with over 50,000 tickets sold. The net result for the current financial year attributed to the Melbourne Royal Show is a surplus of \$1,995,662, a record financial performance.

The Melbourne Showgrounds site activity returned to normal operations in a post pandemic environment with more than 120 external events held including 29 food and beverage events within the new Victoria Pavilion. Rental and associated income from the Venue operation totalled \$15,712,645 and the net result for the current financial year is a surplus of \$2,539,035. A significant contribution to the net Venue operation result was made by the continuation of the COVID-19 testing site for six months and the return of large-scale public and tradeshow events.

Over the past financial year, Melbourne Royal invested a further \$707,000 in capital infrastructure improvements in addition to its minimum annual obligation towards capital investment as specified by the Showgrounds Venue Management Agreement, to further enhance the Showgrounds precinct.

Melbourne Royal continues to support and celebrate agriculture through its range of competitions during the Melbourne Royal Show and throughout the year with its Food and Beverage Award Programs including:

- Australian International Beer Awards
- Australian International Coffee Awards
- · Australian Distilled Spirits Awards
- Melbourne Royal Wine Awards

The operating result of the Company for the year before income tax and joint venture contribution was a surplus of \$4,363,896 (2022: surplus of \$3,872,450). After inclusion of the Melbourne Royal share of loss in the joint venture accounted for using the equity method of accounting, the net deficit of the Company for the year after tax was \$471,806 (2022: deficit \$2,057,510).

Dividends

The Company is limited by guarantee and is prohibited by its Constitution from paying a dividend to its members.

Significant changes in the state of affairs

Other than as described elsewhere in this report there were no significant changes in the Company's state of affairs during the year.

Events subsequent to balance date

There are no matters or circumstance that have arisen since the end of the financial year that have significantly affected, or may significantly affect the company's operations, the results of those operations, or the company's state of affairs in future financial years.

1A) Corporate information

The financial report of the Company For the year ended 31 March 2023 was authorised for issue in accordance with a resolution of the Directors on the same date as the directors' declaration.

The Company is a company limited by guarantee incorporated and domiciled in Australia.

The nature of operations and principal activities of the Company are described in the Directors' report.

The Company's registered office and principal place of business is at Melbourne Showgrounds, Epsom Road, Ascot Vale, Victoria, 3032.

1B) Summary of Significant Accounting Policies

(a) Basis of Preparation

These general purpose financial statements have been prepared in accordance with Australian Accounting Standards and Interpretations issued by the Australian Accounting Standards Board ('AASB') and the Australian Charities and Not-for-Profit Commission Act 2012. The Company is a not-for-profit entity for financial reporting purposes under Australian Accounting Standards. Material accounting policies adopted in the preparation of these financial statements are presented below and have been consistently applied unless stated otherwise.

The financial statements, except for the cash flow information, have been prepared on an accrual basis and are based on historical cost, modified, where applicable, by the measurement at fair value of selected non-current assets, financial assets and financial liabilities. The amounts presented in the financial statements have been rounded to the nearest dollar.

(b) Significant Accounting Judgements and Estimates

The preparation of the financial statements requires management to make judgements, estimates and assumptions that affect the reported amounts in the financial statements. The key estimates and assumptions which are material to the financial reports are found in the following notes:

Property, plant and equipment is recorded at cost less accumulated depreciation and any accumulated impairment losses. Directly attributable costs arising from the acquisition or construction of fixed assets are also capitalised as part of the cost.

Costs incurred on property, plant and equipment subsequent to initial acquisition are capitalised when it is probable that future economic benefits in excess of the originally assessed performance of the asset will flow to the Company in future years. Where these costs represent separate components they are accounted for as separate assets and are separately depreciated over their useful lives.

Assets are depreciated from the date of acquisition or, in respect of internally constructed assets, from the time an asset is completed and ready for use. The residual values, useful lives and depreciation methods are reviewed, and adjusted if appropriate, at each reporting date. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount, and impairment losses are recognised in the Statement of Profit or Loss and Other Comprehensive Income.

The depreciation rates used for each class of asset is calculated on a straight line basis to write off the net cost of each item of property, plant and equipment over their expected useful lives as follows:

An item of property, plant and equipment is derecognised upon disposal or when there is no future economic benefit to the company. Gains and losses between the carrying amount and the disposal proceeds are included in the Statement of Profit or Loss and Other Comprehensive Income.

Estimation of useful lives of assets

Management determines the estimated useful lives and related depreciation charges for property, plant and equipment and finite life intangible assets. The useful lives could change significantly as a result of technical innovations or some other event. The depreciation charge will increase where the useful lives are less than previously estimated lives, or technically obsolete or non-strategic assets that have been abandoned or sold will be written off or written down.

Joint ventures are contractual arrangements between the Company and one or more other parties to undertake an economic activity that is subject to joint control, and the parties that have joint control of the arrangement have rights to the net assets of the arrangement. Joint control only exists when the strategic financial and operating decisions relating to the activity require the unanimous consent of the parties sharing control (the venturers).

A joint venturer shall recognise its interest in a joint venture as an investment and shall account for that investment using the equity method of accounting. Under the equity method the Company will recognise its share of the net assets of the joint venture on a single line in the Statement of Financial Position and its share of the net profit or loss on a single line in the Statement of Profit or Loss and Other Comprehensive Income.

Profits or losses on transactions with the joint venture are eliminated to the extent of the Company's ownership interest until such time as they are realised by the joint venture entity on consumption or sale.

The joint venture structure involves an unincorporated Joint Venture and an incorporated entity known as the Project Company – Showground Nominees Pty Ltd – which has the role of holding the project land on a bare trust basis for and on behalf of the Joint Venture participants. Each participant, the State of Victoria and the Company, has a 50% interest in the Joint Venture and each participant owns 50% of the shares in the Project Company. It has been determined by the Company that the structure and the legal form of the Showgrounds Joint Venture through a separate legal entity, along with the rights and obligations of the joint venture participants as set out in the agreements, indicate that this joint arrangement meets the definition of a joint venture under AASB11.

On inception of the Joint Venture, the State of Victoria made a funding commitment of approximately \$100.7 million and the Company has transferred its land with buildings and improvements to the Joint Venture. The redevelopment of the Showgrounds, which was completed in August 2006, was delivered under the Government's Partnerships Victoria methodology.

Showgrounds Nominees Pty Ltd, as nominee for the Joint Venture, has entered into a number of agreements with the developer of the Showgrounds, referred to as the Concessionaire. These agreements included settlement for the construction of the buildings and infrastructure and the ongoing maintenance and life-cycle costs during the duration of the concession deed of 25 years.

These costs will be met from existing assets of the Joint Venture, some of the future revenue streams from the Showground facilities, and where necessary, funding from the State Government, in accordance with agreements entered into between the Joint Venture, the Joint Venture participants and Showgrounds Nominees Pty Ltd.

Under the State Support Deed – Core Land, the State has undertaken to ensure the performance of the payment obligations in favour of the Concessionaire and the performance of the Joint Venture financial obligations in favour of the security trustee.

Under the State Commitment to Melbourne Royal, the State has agreed to support certain obligations of the Company which may arise out of the Joint Venture Agreement. In accordance with the terms set out in the State Commitment to Melbourne Royal, the State will pay (in the form of a loan), the amount requested by the Company. If any outstanding loan amount remains unpaid at 25 August 2031, which is 25 years after the commencement of the operation term under the Development and Operation Agreement, the Company will be obliged to satisfy and discharge each such outstanding loan amount. This may take the form of a transfer to the State of the whole or part of the Company's participating interest in the Joint Venture.

A general security agreement over the assets of the Company has been entered into between the Company and the State. The Company has granted a security interest over all present and after acquired property to the State as holding for the due and punctual performance of the Company's obligations under or in connection with the charge, the Project Objectives Agreement, the Intellectual Property Agreement or the Events Agreement.

(a) A loan has been provided to the Company by the State of Victoria in accordance with the State Commitment to RAS Deed whereby the State has agreed to provide support with respect to certain obligations of the Company which may arise out of the operations of the Joint Venture Agreement. The loan has been classified as a current liability. However, the Company believes the loan will not be repaid in the short term based on the terms contained in the State Commitment to RAS Deed.

The Company must repay the loan amount together with all accrued interest as, when and to the extent the Company is reasonably able to do so. Any loan amount that has not been repaid during the term must be repaid by 25 August 2031, which is 25 years after the commencement of the operation term under the Development and Operation Agreement.

The interest rate on the loan will be calculated as the aggregate of Treasury Corporation of Victoria's (TCV) cost of funds for the period between the drawdown date and the forecast repayment date of the drawdown (being August 2031) and the cost determined by TCV of an appropriate non-financial corporate BBB rated bond spread to swap. The interest rate at 31 March 2023 was 6.417%.

The loan provided by the State of Victoria is secured by the Company's interest in the Joint Venture.

13. Issued capital

The Royal Agricultural Society of Victoria Limited t/as Melbourne Royal is a company limited by guarantee. In the event of the Company being wound up the liability of its members is limited by its Constitution to an amount not exceeding \$20 while that member is a member, or within one year after that member ceases to be a member.

14. Taxation

Income Tax

Melbourne Royal has an exemption from income tax under Division 50 of the Income Tax Assessment Act (1997).

Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of goods and services tax (GST), except where the amount of GST incurred is not recoverable from the Australian Tax Office (ATO). In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense.

Exemption from GST has been determined under Section 38-250(2)(b)(ii) of the GST Act for certain classes of admissions and entries relating to the Melbourne Royal Show. The determination of GST-free status for admissions and entry fees is carried out on an annual basis.

Receivables and payables are stated with the amount of GST included. The net amount of GST recoverable from, or payable to, the ATO is included as a current asset or liability in the Statement of Financial Position.

Cash flows are included in the Statement of Cash Flows on a gross basis. The GST components of cash flows arising from investing and financing activities which are recoverable from, or payable to, the ATO are classified as operating cash flows.

Service Maintenance Fee

As part of the contractual obligations set out in the RAS Events Agreement, the Company is required to pay a service maintenance fee to the Joint Venture. The service maintenance fee is indexed annually.

The purpose of the payments under the RAS Events Agreement is to contribute to the principal and interest in respect of the Joint Venture's liability to the Concessionaire. The payments are not in the nature of payments for the right to use an asset and do not meet the recognition criteria of AASB 16 Leases. The fees will be expensed over the life of the agreement.

Commercial Events Maintenance and Lifecycle Fees

The Joint Venture has entered into an agreement granting rights to the Company as Venue Manager until August 2031. In consideration for this right the Company is required to pay site maintenance and lifecycle fees for commercial events held on the Showgrounds.

The Company has determined this agreement contains a lease. However, the maintenance and lifecycle fees payable by the Company are based on the number and type of commercial events held within a period with no minimum payments. Consequently, it has been determined this is a variable consideration lease which falls outside the measurement criteria of AASB 16 *Leases*, and the Company will expense these fees in the period to which they relate.

Asset Replenishment Fund

As part of the contractual obligations with the State, the Company is obliged to contribute to the Joint Venture a defined percentage of its cash surplus based on a pre-determined formula as specified in the RAS Events Agreement. Subject to a floor of \$2 million (indexed), the Company must contribute 25% of its cash surplus (before including the 50% share of joint venture results) for the remainder of the operating term.

Based on the Company's result, the current year contribution payable to the Asset Replenishment Fund is \$687,058 (2022: \$611,325).

Capital Investment Obligation

As part of the contractual obligations set out in the Showgrounds Venue Management Agreement 2014 – 2031, the Company is obliged to make a contribution toward capital investment in relation to the Showgrounds. This means capital reinvestment by way of facility modifications or venue fixtures, fittings & equipment of a substantial nature.

The Company must contribute at least \$650,000 (indexed) each year toward capital investment. In any year where the profits exceed \$1,600,000 (indexed), an amount equal to 25% of the profit exceeding the \$1,600,000 (indexed) must also be contributed toward capital investment. Any capital investment obligations not expended must be held in a capital investment account until such time as the funds are required to fund approved capital investment.

During the year ended 31 March 2023, the Company's capital investment obligation is \$944,891. With the substantial investment in the Melbourne Showgrounds site by the Company, including the Building 3 renovation and extension and renovation of the Building 5 kitchen, the Joint Venture Committee of Management agreed that the Company has met its capital investment obligations for the next few years and no further contribution is required for the current year, however an additional \$707,007 was contributed in 2023.

16. Financial instruments

(a) Financial risk management objectives and policies

The company's principal financial instruments comprise receivables, payables, and cash and cash equivalents. These activities expose the company to a variety of financial risks: market risk, interest rate risk, credit risk and liquidity risk.

Financial Risk Management is the responsibility of the Board, which takes advice from the Audit and Risk Management Committee under an authorised Investment Policy. This policy outlines the key objective of achieving the maximum possible investment return within approved investment criteria and risk parameters.

Although the company does not have documented policies and procedures other than an authorised investment policy, the Board manages the different types of risks to which the company is exposed by considering risk and monitoring levels of exposure to interest rates and by being aware of market forecasts for interest rates. Ageing analyses and monitoring of specific credit allowances are undertaken to manage credit risk. Liquidity risk is monitored through general business budgets and forecasts.

Under the State Commitment to RAS Deed, the State of Victoria has agreed to support, in the form of a loan, certain obligations of the Company which may arise out of the Joint Venture Agreement. (c) Risk Exposures and Responses

Interest Rate Risk

The entity's exposure to market interest rates relates primarily to short term deposits held and the loan with the State of Victoria.

Management monitors term deposit rates and balances the achievement of high rates against the flexibility offered by at call funds.

The interest for the loan with the State is accrued at prevailing market rates for commercial loans by a licenced bank in Australia for such amount to counterparties with a similar credit standing to the Company.

Sensitivity analysis

Management are of the opinion that applying a sensitivity analysis rate of 1% is a reasonable estimate of the uncertainty in the market over the next twelve months.
