ALPACAS

REGULATIONS OF ALPACA COMPETITION

401. The Regulations appearing in this Schedule form part of the General Regulations and conditions of entry to an Event at the Royal Melbourne Show. In the event of any inconsistency between the General Regulations and these Regulations, the General Regulations shall prevail to the extent of the inconsistency unless the General Regulations provide otherwise.

CLOSE OF ENTRIES

402. Entries in the Alpaca competition must be received at the RASV's Administration Office located at Melbourne Showgrounds, Epsom Road, Ascot Vale, Victoria 3032 by no later than 5:00pm on Friday 23 July 2010. All entries must be accompanied by the applicable fee, Alpaca Herd Health Status Declaration Form and Registration Certificate (both sides) of each Exhibit entered.

403. The onus is entirely on the Exhibitor to submit particulars on time. There will be no reminder from RASV staff.

404. In accordance with General Regulation 8.2, the RASV reserves the right to amend, consolidate or cancel classes offered in this competition schedule.

ENTRY FEES

405. Entry fees for Alpacas and Fleece will be as follows (straw inclusive):

- \$50 per animal (GST free) for Members
- \$75 per animal (GST free) for Non-members
- \$15 per fleece (GST free) for both Members and Non-members

406. The entry fee entitles the Exhibitor to enter the animal in all eligible classes. Please specify selected classes on enclosed Entry Form.

CATALOGUES

407. Each exhibitor is to pre purchase one catalogue for \$10.00 with their initial entry. Upon arrival at the Showgrounds you will be given your catalogue, which will be included in their Exhibitor Pack. Additional catalogues can be purchased from the Superintendents Office.

TRUCK PARKING

408. Parking for trucks and floats is available in the VRC Racecourse car park. Apply by completing the relevant section on the Entry Form and forward the fee with the competition entry fee.

409. Truck parking fees for 2010 will be:

410. Please indicate on the Entry Form the dimensions and make/model of your truck/trailer.

411. There is to be no camping in the VRC Truck Park under any circumstances and the area must be vacated by 8:00am Monday 28 September 2010.

412. Any vehicle, including trucks, stock transports, trailers, and horse floats, located on the Showgrounds, or any area leased by the RASV, shall be at the sole risk of the owner. The RASV accepts no responsibility for any loss or damage, including loss or damage caused by negligence of the RASV, its officers, employees, or agents to any vehicle, or the contents of any vehicle, located on the RASV's property or in the area leased by the RASV.

ARRIVAL AND DEPARTURE OF EXHIBITS

413. Arrival and Departure times are as follows for Alpacas:

Arrival: Saturday 25 September between 6:00am and 9:00am

Departure: Monday 27 September from 6:00pm - 10:00pm for Interstate travelers, and for long distance Victorian travelers; from 8:00pm - 10:00pm and between 6:00am and 8:00am on Tuesday 28 September. All remaining exhibitors from 5:00pm on Tuesday 28 September.

PERIOD OF EXHIBITION

414. Animals must be penned by 9:00am Saturday 25 September 2010.

415. Alpacas will be permitted to leave only after 6:00pm Monday 27 September 2010.

416. All Exhibits must be removed by 8:00pm Tuesday 28 September.

EXHIBITORS' MEETING

417. At the direction of the Chief Steward, Exhibitors are to attend a meeting on Saturday 25 September 2010 in the Alpaca Show Ring. Exhibitors will be notified of the time of the meeting in subsequent documentation.

BEDDING

418. No bedding other than straw may be used in pens.

419. For the convenience of Exhibitors, fodder merchants will attend the Showgrounds for the purpose of accepting orders for stock fodder and the delivery of stock fodder must be made before 8:00am each day during the Show.

EXHIBIT/STOCK ATTENDANT PASSES

420. An Exhibit Ticket will be issued prior to the Show.

421. The Exhibit Ticket must be produced at the gate, when it will admit the Exhibitor and Exhibits on to the Showgrounds. It must be retained, and again produced when the Exhibit leaves the Showgrounds. Stock Attendant Passes will be issued by the Superintendent at his office on the Showgrounds once Exhibits have been penned.

422. Stock Attendant Passes will be issued according to the following formula:

One Stock Attendant Pass for every Exhibitor.

- Additionally: One Stock Attendant Pass for three to five Exhibits
- Two Stock Attendant Passes for six to ten Exhibits
- Three Stock Attendant Passes for eleven or more Exhibits

CLEANLINESS OF PENS

423. Mucking out of pens is to be carried out between 8:00pm and 7:00am. These times will be strictly enforced.

424. Exhibitors must keep the pens allotted to their animals clean and give proper attention to their stock throughout the Show. Exhibitors are advised to provide their own feed and water containers.

ADVERTISING

425. Each Exhibitor is permitted to display one sign 60cm x 120cm in size provided that such sign carries only the stud name, address, telephone number, facsimile number, e-mail address and website address. Sale signs are not permitted.

426. Display of Show ribbons other than those awarded at the 2010 Royal Melbourne Show is prohibited. Decoration of pens is encouraged.

SMOKING

427. Smoking and naked flames are at all times prohibited in Lockers and Pavilions.

REGISTRATION

428. A copy of each Exhibits Registration Certificate (both sides) must be included with the Entry Form. Failure to provide a Registration Certificate with the Entry Form will deem that animal ineligible for Exhibition at the Show.

429. Only the registered owner of an Exhibit, or his/her authorised agent may sign an Entry Form.

HEALTH REGULATIONS

430. All entries must be accompanied by the Alpaca Herd Health Declaration Form signed by the Exhibitor or authorised agent, and a Government Veterinary Officer if applicable. Failure to sign the Alpaca Herd Health Declaration Form will render all Alpacas of an Exhibitor ineligible to be exhibited.

431. The 2009 Alpaca Competitions will be conducted under the guidelines as set out in the Johne's Disease Market Assurance Program (AlpacaMAP).

432. Alpacas traveling interstate must comply with the requirements of Victorian legislation.

EXERCISING OF ANIMALS

433. Alpacas are to remain in their pens during the day and exercising is only allowed at specified times (out of public hours, before 9:00am and after 10:00pm) or at times nominated by the Superintendent.

COMPANION ANIMALS AND DOGS

434. Animals not entered for competition, with the exception of cria at foot, will not be permitted onto the Showgrounds. Companion animals are not permitted.

No dogs (except guide dogs) are permitted into the precinct of where Show animals are being penned or shown.

INSPECTION OF EXHIBITS

435. Inspection of all Alpacas will take place on Saturday 25 September 2010 between 8:00am and 11:00am.

436. All Alpacas must be registered with the Australian Alpaca Association Ltd and carry an approved brass tag showing the Alpaca's IAR number.

437. A representative of the Australian Alpaca Association Ltd (AAA) under AAA Rules shall put forward nominations to the RASV for Inspector appointments and these nominations will be considered by the RASV.

438. Every animal exhibited in the Alpaca section will be subject to inspection carried out by an Inspector appointed by the RASV.

439. The Inspector or Inspectors appointed by the RASV shall then examine all Alpacas for genetic faults, colour, class and IAR number. Current Alpaca passports accepted.

440. If there is no IAR tag present in the ear of an Exhibit, official Australian Alpaca Association Ltd confirmation (in hard copy) must be provided by the owner to the Chief Steward that the ear tag has been recently lost and that the new tag has been ordered and paid for. Replacement tag orders and payments must be lodged with the National Office a minimum of one week before the date of Show. Failure to present such advice at inspection will result in disqualification of the animal.

441. No Exhibitor to the best of their knowledge shall exhibit any alpaca showing any signs or symptoms of disease at the time of exhibition. All male alpacas must be completely entire and deemed physically sound. Any alpaca not deemed to be completely physically sound by the appointed RASV Inspector or a Veterinary Surgeon shall not compete.

442. The Inspector or Chief Steward will classify all entries for colour, and has the power to transfer an Exhibit to the class which, in their opinion, should have been entered. The Chief Steward will combine or split classes as he / she sees fit.

443. Alpacas not in their allotted pens and available for inspection at the official times may be disqualified by the Chief Steward. Exhibitors must be in attendance at time of inspection and will be required to assist.

444. Exhibits of Huacayas must carry a minimum fleece length of 50mm and a recommended maximum length not exceeding 130mm. The minimum fleece length for Suris is 75mm and fleece length will be assessed by the Judge.

Note: Huacaya 12 months and older must be shorn regularly so that no more than 15 months fleece is carried at the time of showing.

445. Any animal found to have lice infestation must be removed from the Showgrounds immediately along with any other Alpacas present that belong to the same Exhibitor.

CORRECT ANIMAL COLOUR CLASSIFICATION

446. An Alpaca is to be shown in the appropriate colour class, when it is predominantly that colour. Any colour variations will be assessed at the Judge's discretion.

447. A predominantly grey Alpaca (grey, rose grey / roan) is to be shown in a grey class, whether or not it has any other coloured spots present, and any colour variations will be assessed at the Judge's discretion.

448. Exhibits shall not have fleece of a different colour to that of the blanket removed from an animal to a level below that of the blanket fleece.

AGE OF ALPACA

449. Alpacas must be entered into the correct class at their age on the first day of judging, Saturday 25 September 2010.

FLEECES

450. Fleeces are to be lodged with the Fleece Steward Jillian Holmes by 5.00 pm on Sunday 12 September at Jigarú Alpacas, 10 Murrays Rd

Langley Vic 3444. Fleeces entered in the Colourbration Show can be delivered to Jillian Holmes at the conclusion of that Show.

451. Only one fleece that has been shorn in the 18 months prior to the Show may be shown from any one animal. It is recommended that fleeces be placed in bags, made of satin or similar material, or heavy duty plastic. Plastic garbage bags should be avoided.

452. All fleeces being shown, including wether fleeces, must be the bona fide property of a financial member of the AAA.

453. Exhibitors when submitting fleeces must attach to the fleece the number supplied for that class (no names).

454. Winning fleeces will be displayed at the Showgrounds for the duration of the show (17 - 27 September 2010).

JUDGING

455. The following regulations shall be read subject to General Regulations 10.1 to 10.6 of the General Regulations.

456. Judging Times are as follows:

Alpaca Fleece: Pre Show – Wednesday 15 September 2010

Junior Female Huacaya Saturday 25 September, from 1:00pm

Junior Suri Sunday 26 September, from 10:00am

Junior Judging Sunday 26 September, from 1:00pm

Junior Male Huacaya Sunday 26 September, from 1:00pm, proceeding Junior Judging

Suri Monday 27 September, from 9:30am

Huacaya Monday 27 September, from 1.00pm

Supreme Suri Monday 27 September, from 1.00pm proceeding Huacaya judging

Supreme Huacaya Monday 27 September, from 1.00pm proceeding Huacaya judging

457. Progeny classes Tuesday 28 September, from 10:00am

458. Best of Colour Tuesday 28 September, from 10:00am, proceeding Progeny Class

459. Junior Handing Tuesday 28 September, proceeding Progeny Class

460.

461. Section 3 through to Section 10 will be followed by all section champions "1-10" for the Supreme Champion.

462. The Huacaya Sire Progeny will proceed after the judging of the Huacaya Supreme Champion.

463. The Suri Sire Progeny will proceed after the judging of the Suri Supreme Champion.

464. The Judge's decision shall be final and the Judge has the power of withholding prizes from any Exhibitor not deemed worthy of that prize.

465. All Exhibitors shall, on the day of the Show, obtain their pen position and class numbers from the Shed Steward. Exhibitor class numbers of the Exhibit must be worn and clearly displayed by the handler whilst in the Show Ring and must show age of animal in months.

466. All handlers showing animals must be competent in the handling of their Exhibit, or removal from the Show Ring may be requested by the Judge. It is recommended that children not Exhibit large animals that they cannot control.

467. All Exhibitors must place their animals in the pens allotted by the Stewards and must not be moved or removed except by order of the Chief Steward.

MISCONDUCT OF EXHIBITORS AND MEMBERS

468. A violation of any rule by the Exhibitor shall be reported to the Chief Steward in writing by either the Judge, a steward or exhibitor within one hour of the alleged incident occurring.

469. Misconduct may also be reported by the Judge, a Steward or Exhibitor to the Chief Steward in respect of actions of an exhibitor or member present at the Show that is considered to be prejudicial to the industry. Such actions may include but not be limited to:

a) A demonstration of dissatisfaction with a Judge's decision, including refusal to accept an award.

b) Altercations with Show Officials, Exhibitors or the general public.



c) Abusive or foul language or rude gestures in public and the mistreatment of an animal.

470. Written complaints shall be lodged with the Chief Steward within one hour of the alleged incident occurring. Written complaints received by the Chief Steward shall be immediately investigated and if sufficient grounds for the complaint are confirmed the matter shall be reported to the AAA National Secretary for appropriate action under the AAA Grievance Procedure.

PROTESTS

471. The following regulations shall be read subject to General Regulations 11.1 to 11.7 of the General Regulations

472. Only an Exhibitor may lodge a protest against another Exhibitor or a Show official. The protest shall be lodged in writing together with a deposit of \$50, which shall be refunded if the protest is upheld.

473. The sole grounds for a protest shall be a breach of the Regulations and protests shall be lodged with the Chief Steward within one hour of the alleged incident occurring.

The Chief Steward shall set up a Protest Committee prior to the commencement of the Show. The Committee shall comprise the Chief Steward as the Chair and two ordinary members not associated with the alleged incident. A meeting will be convened within 30 minutes of the protest being received. The Protest Committee shall immediately investigate the protest and if found to be valid initiate appropriate action.

DRESS CODE

474. All Exhibitors leading stock in the Judging Ring or on Parade shall wear a white coat, black trousers or skirt and clean closed black or brown shoes. No shorts or short dresses, open shoes or hats.

475. Such white coat uniform must in no way show any insignia or any descriptive markings indicating the Exhibitor's name and/or stud name or prefix.

476. The Chief Steward may disqualify an Exhibitor for incorrect attire.

EXCESS ENTRIES

477. In the event of more entries being received than can be accommodated, Alpaca entries may be reduced. If necessary, the number of Alpacas from any one Exhibitor may also be reduced to a figure determined by the RASV. The Exhibitor shall have the right to nominate the Alpaca(s) to be withdrawn should this reduction be necessary.

PRIZES

478. Ribbons may be awarded up to 6th place as follows:

- Up to 10 exhibits per class: 1st, 2nd & 3rd ribbons.
- 10 to 20 exhibits per class: 1st, 2nd, 3rd & 4th ribbons.
- Over 20 exhibits per class: 1st, 2nd, 3rd, 4th, 5th & 6th ribbons

The Judge is under no obligation to award the prize where he / she considers in his / her absolute discretion that such prize, or prizes, are not to be awarded.

SIRES PROGENY CLASSES

479. Group of three males, females or males and females (not wethers), six months and over. Not necessarily owned or bred by the one Exhibitor, but all the progeny of the one sire and drawn from the Ordinary classes.

480. Only one progeny from any one dam may be shown in each sires progeny group unless the progeny have been born at least eleven months apart.

481. Entries close for Sires Progeny Groups at a time determined by the Chief Steward and the Sheep Superintendent. Exhibitors will be advised upon arrival at the Showgrounds of this time.

JUNIOR JUDGING

Judging will take place at 1:00 pm on Sunday 26 September 2010.

482. Competitors to be aged between 15 - 25 years

483. Entrants are advised to attend an approved Alpaca Junior Judging workshop prior to the Junior Judging competition.

484. The competition will be conducted as follows:

- a). One group of four animals will be judged by the competitors.
- b). There will be one visual class and one oral class.
- c). Each competitor's performance will be observed by an Over Judge who will allocate credit marks.

d). The judging criterion to be used is that set out by the Australian Alpaca Association Inc.

485. Dress code applies.

JUNIOR HANDLER CLASS

486. Entries accepted on the day of judging at a time nominated by the Chief Steward. Exhibitors will be notified of this time upon arrival at the Showgrounds.

MOST SUCCESSFUL EXHIBITOR AWARDS

487. There are separate Awards for the Huacaya and Suri Competitions.

488. The Most Successful Exhibitor Award will be calculated as follows:

- Classes with 1 to 10 entries: 1st, 3 points; 2nd, 2 points; 3rd, 1 point.
- Classes with 11 to 30 entries: 1st, 4 points; 2nd, 3 points; 3rd, 2 points; 4th, 1 point.

489. Placings in Sire's Progeny Class and Fleece Classes will not be taken into consideration when deciding these awards.

490. In the event of a tie, two points will be allotted for Champion awards and one point for Reserve Champion awards. If a tie still exists, a count back approved by the RASV, will be made to determine the winner.

491. RASV Sash will be awarded to the Most Successful Huacaya Exhibitor (S001) and Most Successful Suri Exhibitor (S002).

THE BEST PREPARED AND MAINTAINED TEAM AWARDS

492. The aim of the award is to encourage Exhibitors to display and maintain their teams in a manner befitting the Alpaca Industry. The RASV will provide a Sash to the successful Exhibitor (S003).

493. Judging will take place from Saturday 25 to Tuesday 28 September 2010.

Points will be awarded for the following items:

a) Groomed appearance of Alpaca	10 points
b) Condition and economic use of bedding	10 points
c) Condition of floors below bedding	10 points
d) Absence of excreta	5 points
e) Condition of feeders	5 points
f) General tidiness of pens	5 points
g) Attendance, public relations	10 points
